- 1. By way of this Appeal filed under Section 252(3) of the Companies Act, 2013, the Appellants above named seek for restoration of the name Company, M/s. A2VP Distributors Private Limited in the Register of Companies maintained by the Registrar of Companies, Gujarat, Ahmedabad ["ROC" for short].
- 2. The facts in brief, which necessitated the Appellants Company to file this Appeal, are as follows;
- 2.1. It is stated that the ROC vide Public Notice No. ROC/STK/5A dated 25.4.2017 issued in Form No. STK-5 followed by final notice No. ROC/AHMD/248(5)/STK/PUB/1 dated 21st June, 2017 issued under sub-section (5) of Section 248 of the Companies Act has struck off the name of the Company from the Register of Companies.
- Appellant Company are partners of a partnership firm, namely M/s. Suyog Sales and Marketing. The said partnership firm was engaged as a Distributor of products of a Company named M/s. Konka Group Company Ltd; there were inter se disputes between the said Company and the Members of the Appellant Company; the matter was referred to arbitration; the litigation is pending before the Hon'ble Delhi High Court; due to continuous legal proceedings which are going on and final orders are pending the Company could not proceed

with any business activities; and the Company has filed Audited Financial Statements and Annual Returns with the ROC upto financial year 2011-12.

- 2.3. The Appellants have filed copies of Audited Financial Statements for the financial years 2012-13 to 2016-17; copies of Acknowledgements of Income Tax Returns for the Assessment Years 2016-17 and 2017-18; copy of Bank Statement and other documents.
- 3. On Notice being issued and served upon the ROC, the ROC filed Representation through his Deputy Registrar on 25<sup>th</sup> January, 2018. The ROC, while denying the allegation made and contention raised in the Petition, has submitted that the Company had failed to file statutory returns since 31.3.2013 and therefore the Company's name was struck off from the Register of Companies.
- 4. In pursuance of the Notice of this Tribunal, the Appellants filed an Affidavit dated 16<sup>th</sup> January, 2018 showing the status of the Directors of the Company and the status of Bank Account.
- 5. This Appeal is filed by the Appellant Company and one of the Members of the Company under Section 252(3) of the Companies Act. The Appellants are entitled to file Appeal seeking restoration of

of its name. Therefore, this Appeal is maintainable. The Company, M/s. A2VP Distributors Private Limited was struck off on 21st June, 2017 from the Register of Companies and the same was published in the Gazette of India. This Appeal was filed on 18th December, 2017. Therefore, this Appeal is within time.

- From the material available on record, the only reason for 6. striking off the name of the Company, M/s. A2VP Distributors Private Limited is that the Company has failed to file its statutory returns since the Financial Year 31.3.2013.
- The materials on record also go to show that the Company is an ongoing concern and has been doing business. The Registered Office of the Company is situated at Shalin Bunglows, Thaltej, Ahmedabad, Gujarat.
- Considering all the aforesaid aspects, this Tribunal is of 8. the considered view that it is just and equitable to issue directions to restore the name of the Company, M/s. A2VP Distributors Private Limited in the Register of Companies maintained by the ROC, Gujarat, Ahmedabad and to remove the defects of disqualification if any as Directors, imposed under Section 164(2) of the Companies Act, 2013.
- In view of the above, the instant Appeal is allowed, and the the Registrar of Companies (Gujarat, Dadra and Nagar Haveli) is

directed to restore the name of the Company in the Register of Companies upon Appellants complying with the following conditions;

(i) The Appellants shall file all over due statutory returns with

fee and additional fee as required under the Companies Act;

(ii) The Appellants shall publish a Notice in leading

newspapers circulating in the District as well as in the Official

Gazette of the Government of India with regard to the restoration of

the name of the Company in the Register of Companies maintained

by the Office of the Registrar of Companies, as per the draft notice

approved by the Registrar of Companies at the expenses of the

Appellants;

(iii) The Appellants shall also pay an amount of Rs. 10,000/-

to the Ministry of Corporate Affairs by way of Demand Draft drawn

on Nationalised Bank towards the cost incurred by the Government

in striking off the name of the Company within 3 (three) weeks from

the date of this order.

10. The Appeal stands disposed of accordingly.
