- 41. Heard Shri Ravi Kapoor, learned PCS with Shri Dilip Kumar Jain learned PCS appearing for the petitioner companies.
- 42. It has been submitted that a common representation on affidavit dated 28th December, 2017 has been received from the Regional Director, North Western Region, Ahmedabad. The said representation contains no adverse observations. Vide Paragraph 2(a), the Regional Director made observation regarding nonsubmission of Working Sheet for calculation of Share Exchange Ratio of the Scheme of Amalgamation. The Transferee Company has filed the said working along with the Certificate for the Valuation of Shares and Share Exchange Ratio as certified by M/s Rajesh Kumar Jain & Co., Chartered Accountants, dated 5th July, 2017 by Affidavit dated 13th January, 2018. In respect of the observation in Paragraph 2(b) regarding requirement of undertaking from the Petitioner/Transferee for compliance of section 232(3)(i) of the Companies Act, 2013 for enhancement of Authorized Share Capital of Rs. 4,53,00,000/-, the same has been furnished by the Petitioner Company confirming that it would pay the differential amount of fees. In respect of observation in Paragraph 2(d), separate affidavits dated 13th January, 2017 by the concerned companies were furnished confirming that no unaccounted money created through security premium account during any of the previous years by the respective Transferor Companies. In Paragraph 2(e) of the representation, the Regional Director has observed that as per

the Report of the Registrar of Companies, that there are no complaints against petitioner companies and there is no complaint/ representation against the Scheme of Amalgamation of petitioner companies.

- 43. The Official Liquidator, of Madhya Pradesh has submitted a common representation dated 1st February, 2018. The said representation contains no adverse observations. The Official Liquidator has also commented that the interest of all employees of Transferor Companies have been protected in the Scheme of Amalgamation and confirmed that the said office has not received any complaint against the proposed Scheme.
- 44. In compliance of the representation made by the Official Liquidator, the Petitioner/Transferee Company has furnished an Affidavit dated 2<sup>nd</sup> February, 2018 confirming that the Petitioner/Transferee Company undertakes to make necessary payment of cost of the Scheme of Amalgamation in respect of all the Transferor as well as the Transferee Company and to abide the required procedures of the relevant laws while taking credits of the Taxes on all the Transferor Companies, as may be required.
- 45. The Official liquidator and the Regional Director have not raised any objection on the Scheme of Amalgamation and the

Income Tax Authority has also not submitted any representation against the Scheme, for which necessary notice was duly served.

- 46. Accordingly, there are no adverse observations from the aforesaid authorities and the petitioners have filed proper affidavits in reply accepting to comply with all the legal requirements. No representation has been received from any other Regulatory Authorities. Hence, it is assumed that the said authorities have no objection to the proposed Scheme.
- 47. The Transferee company had produced on record, at the stage of Application, copies of certificates issued by the Auditors stating that the accounting treatment contained in the Scheme is in compliance with all the applicable Accounting Standards notified by the Central Government under Section 133 of the Companies Act, 2013.
- 48. Considering the entire facts and circumstances of the case and on perusal of the Scheme and the documents produced on record, it appears that the requirements of the provisions of Sections 230 to 232 of the Companies Act, 2013 are satisfied. The Scheme appears to be genuine and *bona fide* and in the interest of the shareholders and creditors.
- 49. In the result, these Petitions are allowed. The Composite Scheme of Amalgamation Annexure P-1 to the petitions is

Private Limited, Shri Venktesh Entertainment Private Limited, Navin Chitra Pictures & Builders Private Limited, Kulthana Valley Projects Private Limited, Solitaire Club Private Limited, Vaishnavi Insurance Consultants Private Limited and Brilliant Technology and Constructions Private Limited shall stand dissolved without winding up.
- 51. It is ordered that the Transferee Company shall take responsibility for payment of Income Tax or any other tax that

arises to be made to any statutory authorities after implementation of the Scheme of Amalgamation.

- 52. The Transferee Company shall preserve Books of Accounts, papers and other records of all the Transferor Companies 1 to 10 and that the same will not be disposed of without prior permission of the Central Government as per the provisions of Section 239 of the Companies Act, 2013.
- 53. The Transferee Company shall comply with the requirements of the Accounting Standards as required u/s 133 of the Companies Act, 2013.
- 54. Fees of the Official Liquidator are quantified at Rs.10,000/- each in respect of the Transferee Companies. The said fees shall be paid by the transferee company, ie. Brilliant Estates Limited.
- 55. Filling and issuance of drawn up order is hereby dispensed with. All concerned authorities to act on a copy of this order along with the scheme duly authenticated by the Registrar of this Tribunal. The Registrar of this Tribunal shall issue the authenticated copy of this order along with Scheme immediately.
- 56. The Petitioner/Transferee Company is further directed to lodge a copy of this order and the Scheme duly certified by the

Maran



Registrar of this Tribunal with the all the concerned authorities, as required, for the purpose of the transfer of rights and obligations to the transferee Company, wherever applicable.

- 57. The petitioner companies shall comply with Rule 17(2) of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 with respect to filing of a copy of this order, along with a copy of the Scheme with the concerned Registrar of Companies, electronically in form INC-28, in addition to physical copy, as per the relevant provisions of the Companies Act, 2013.
- 58. Any person interested shall be at liberty to apply to the Tribunal in the above matter for any direction that may be necessary.
- 59. These petitions are disposed of accordingly.
