ORDER

The present application is moved by the Financial Creditor, ICICI Bank Ltd. u/s. 60(5) of I&B Code read with Rule 32 of National Company Law Tribunal Rules for

interlocutory orders of injunction against the Resolution Professional, by filing precipe for urgent hearing today. Matter is slated to be heard at 2.00 p.m.

It is the case of the applicant that there is urgency in this matter as the COC meeting is to be held on 20.02.2018 wherein the resolution plan will be put for voting. It is further contended that resolution plan is not in conformity with law. The applicant is aggrieved by the rejection of its claim 2 and thereby deprived from exercising its appropriate voting rights.

Ld. Counsel for the applicant made various submissions in support their contentions and led the Bench to various provisions of law as well as cited three judgments:
