- Upload the related documents to the compliance memo
- All the original documents with memo (2 sets) may please be sent by speed post mentioning e-filing number.

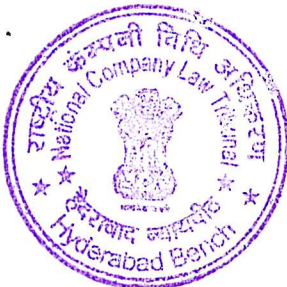

After filing petition/ re-submission no email is required to be sent, since the updated status is regularly checked in e-portal for further necessary action.

All applicants/ petitioner may also send petition/ IAs/ Caveat copy (2 sets) by speed post along with original.
