**1 IBA/13/KOB/2020**

Learned counsel for the Operational Creditor Smt. Jayanthi K. Shah as well as learned counsel for the Corporate Debtor Shri P.V.George appeared in the VC. Order pronounced. IBA is admitted and IRP appointed vide separate order.

**2 REPORT NO. 28/2020 IN TIBA/34/KOB/2019**

Learned RP Shri Sathiq Buhari appeared in the V C.
