It is also reported that the Petitioner Company has filed its statutory returns viz: Annual Returns and Balance Sheets up to the Financial Year ended 31.03.1999. Thereafter the Company defaulted in filing its statutory returns. On the other hand, the report stated that the status of the Company is 'active'.

On perusal of the records it appears that the address of the Petitioner Company given in the Petition is S.T.Reddiar and Sons (Quilon) (P) Ltd, Registered Office at Mini Towers, S.R.M.Road, Kochi-18. Record reveals that repeated notices sent to the above address were returned stating that "no such office at Mini Tower". Therefore, it appears that there is little difference in the address given by the

Petitioner in the Company Petition and the Report of RoC. Registry is directed to issue notice again to the petitioner with Speed post with A/D in the address mentioned by RoC in his report, ie: M/s. S.T.Reddiar & Sons Quilon Private Limited, Registered Office: 43/2722, Heritage, S.R.M.Road, Cochin, Kerala - 682018.
