Learned proxy counsel for the petitioners Shri E.Narayanan and learned counsel for the respondent Shri P.M.Unni Namboodiri appeared through VC. Pleadings are complete in this case. Today the case is posted for hearing. The prayers in the CP are to wind up the Company under Section 271(d) of the Companies Act 2013, award the cost and expenses to the petitioners incurred for filing the winding up petition and to pass such further or other orders as this Tribunal may deem fit and proper.

The respondent in his counter has prayed that in case the assets of the company are put for sale, the 1st respondent may be given preference to purchase the same. The respondent has also prayed that while passing orders for winding up of M/s. Baksons (India) Pvt Ltd this Tribunal may be pleased to pass necessary orders protecting the first respondent's interest also.

I have heard the submissions of learned proxy counsel for the petitioner as well as learned counsel for the respondent through Video Conferencing. In view of the submissions in the Counter Affidavit, learned counsel for the petitioner sought two months time for filing the settlement memo. Next date fixed for final hearing on 26.8.2020, before that date both the parties are directed to file their settlement memo.

Learned senior counsel for the petitioners Shri Aravindh Pandian and learned PCS for the respondents Shri K.S.Ravichandran appeared through VC. The names of the Independent Forensic Auditor suggested by the petitioners are on record. Learned counsel for the Respondents submitted that they have filed an appeal CA(AT)/87/2020 before the Hon'ble NCLAT, which is coming up for hearing on 3.7.2020 and hence prayed for an adjournment. The learned senior counsel vehemently opposed the adjournment request stating that the learned PCS for the respondents is unnecessarily delaying the disposal of the matter. Learned counsel for the appellant Shri A.C.Venugopal and learned counsel for the Administrator (R1) Shri Manuel Vivera appeared through VC. None has appeared for other respondents. It appears from records that the counter filed by Respondents 4, 6 to 9, 11, 13 and 18 was found defective due to non-notarisation, which has been returned to the learned counsel for the aforesaid respondents.
