1 REPORT NO.50/KOB/2020 IN TIBA/01/KOB/2019

Learned Liquidator Shri Shawn Jeff Christopher appeared through Video Conference. The Liquidator submitted his Progress Report for the first quarter ended 31st March 2020. He submitted that he could not complete the liquidation process due to the Covid 19 problems. Report of the Liquidator is taken on record.

2 TMA/42/KOB/19 (MA/ 450/IB/18(C.B.)) IN CP/689/IB/2017/(C.B.)

Learned RP and learned PCS for R2 to R4 Shri Krishnan Unni appeared through VC. It appears from records that MA/450/IB/2018 was filed before NCLT Chennai Bench and counter in the said MA was filed by the respondents. Now the RP filed an addendum to the MA praying to consider the addendum to be part of the original application MA/450/IB/2018. Learned counsel for the respondents submitted that he has not received the copy of the addendum to the application. Learned PCS for the respondents submitted that he do not have any objection to allow the prayer 1 and 2 mentioned in the IA if the document (agreement for sale of shares executed between Mr. Sulaiman Assanar Kunju and Mr. Jahufar Rawther Abdul Aziz 1st and 3rd petitioner respectively and Ansaruddin Haneefa, 2nd respondent) is accepted. Accordingly, IA/61/KOB/2020 is allowed. Learned PCS for the petitioner submitted that he will be filing the rejoinder in the CP within 14 days and prayed to list the matter preferably after 3 weeks for hearing.
