1 REPORT NO. 51/2020 IN TCP/44/KOB/2019

Shri Philip Mathew appeared for R1 & R2 and Shri A. Gopalakrishnan of M/s. K. Venkatachalam Aiyer & Co., Chartered Accountants appeared through VC.

Vide order dated 21.4.2020 in TCP/44/KOB/2019 this Tribunal appointed M/s. K.Venkatachalam Aiyer & Company, Chartered Accountants to investigate into the accounts and affairs of R1 Company M/s. Meenachil Hotels and Resorts Pvt Ltd for the period from 01.4.2015 to 31.03.2019 and to furnish a report on the transparency of the accounts and affairs of the company during such period. M/s. K.Venkatachalam Aiyer & Company filed its Memorandum stating that they sent a letter dated 27.5.2020 addressed to the company requesting them to provide necessary documents and details to carry out the investigation. In response to the said letter, Shri K.T.Thomas, Managing Director of the Company informed them through email dated 2.6.2020 that the Company intends to file an appeal against the Order of this Tribunal before competent authority and requested to wait until further developments in this regard. The Company did not furnish any information or documents to M/s. K.Venkatachalam Aiyer & Company as requested vide their email dated 27.5.2020. Under the circumstances M/s. Venkatachalam Aiyer & Company could not commence their investigation into the affairs of the company.

Meanwhile the learned counsel for R1 & R2 also submitted that the respondents are filing an appeal before the NCLAT against the order of this Tribunal and hence sought an adjournment for three weeks.

M/s. K.Venkatachalam Aiyer & Company have also filed a Memorandum on 7.5.2020 to revise the fee of Rs.1,00,000/- (Rupees one lakh only) specified in the order of this Tribunal taking into consideration of the volume and complex nature of the engagement. M/s. K.Venkatachalam Aiyer & Company is directed to complete their task as ordered by this Tribunal and submit their bill. Revision of fee, if any, can be considered in accordance with the fee prescribed by the Institute of Chartered Accountants of India.

Report of M/s. K. Venkatachalam Aiyer & Company is taken on record. In view of the submissions of M/s. K. Venkatachalam Aiyer & Company and the learned counsel for R1 and R2, the matter is adjourned to 27.7.2020.
