#### 1 IA/7(KOB)/2020 IN TCP/7/KOB/19

Learned counsel for the applicant as well as respondents in IA submitted an email stating that since the case involves serious questions of law and also considering the voluminous documents and pleadings, it may not be possible to hear the case via Video Conferencing. Hence both sides sought adjournment through email and requested the matter to be heard through physical hearing. Allowed. List on 7.9.2020.

#### 2 TCP/7/KOB/19

Learned counsel for the petitioner as well as respondent 1 and 2 submitted an email stating that since the case involves serious questions of law and also considering the voluminous documents and pleadings, it may not be possible to hear the case via Video Conferencing. Hence both sides sought adjournment through email and requested the matter to be heard through physical hearing. Allowed. No response from R3 & R4. List on 7.9.2020.

#### 3 TCP/50/KOB/2019

Learned counsel for the petitioner Shri Ramalingam V.A. and learned counsel for R1 Smt Sindhu Santhalingam appeared through VC. It appears from records that Shri S.Sivakumar, Registered Valuer who has been engaged by this Tribunal to ascertain the true value of the Company and Equity Shares has submitted an email on 1.7.2020 stating that he was allowed to conduct the second visit of the premises only on 23.6.2020. Still certain information is pending from the respondent. He has been confirmed by respondent that the same will be provided by noon of 1.7.2020. He also submitted that he needs minimum two working days to complete the valuation works.

On perusal of the records, it appears that R2 to R5 have not yet appeared or made any representation before this Tribunal. Learned counsel for R1 submitted that she

will appear for R2 and shall file Vakkalath shortly. It also appears from records that notices were duly served to R6 and R7 on 20.9.2019 and 21.9.2019 respectively. But they neither appeared nor made any representation. **Therefore, R6 and R7 are hereby set ex-parte in this case.** 

The petitioner is directed to send notices to R3 to R5 through speed post with acknowledgement card and also through email and submit proof of service with an affidavit before the next date fixed positively. List on 4.8.2020.

#### 4 TCP/54/KOB/19 (TCP/108/16)

Learned counsel for the petitioner submitted an email stating that the documents ordered to be produced by this Tribunal has not been produced by the respondents, apparently due to Covid 19 and that the case records consist of several volumes of pleadings, which makes the case unsuitable for disposal through VC.
