

1. This application is filed under Section 12 r.w. Section 60(5) of Insolvency and Bankruptcy Code, 2016 (hereinafter referred to as "IBC, 2016") and under Rule 11 of NCLT Rules, 2016 seeking exclusion for a period of 606 days from CIRP period.

2. The facts, in brief, are that the Corporate Debtor was admitted into Corporate Insolvency Resolution Process (hereinafter referred to as "CIRP") vide order dated 15.01.2019. Initial period of 180 days got over on 14.07.2019. It was further extended by 90 days and extended period got expired on 11.10.2019. On 07.10.2019,

one resolution plan was approved by COC and application for approval of resolution plan before this Authority was filed on 21.10.2019. However, such resolution plan was not approved as one unsuccessful resolution applicant filed an application against the eligibility of resolution applicant whose plan had been approved by COC. This litigation consumed 504 days and on 06.01.2021, this Adjudicating Authority directed the Resolution Professional to re-look into the eligibility of resolution applicant and also to consider other resolution plans including resolution plan of the unsuccessful resolution applicant. On 22.01.2021, the COC meeting was held and resolution was passed seeking exclusion of certain period from CIRP to complete the proceedings as directed by this Adjudicating Authority vide order dated 06.01.2021. However, on 08.03.2021, this Adjudicating Authority dismissed this application exclusion of certain period for the reason that two plans were rejected by COC. IA No. 722 of 2019 which was filed for approval of earlier resolution plan was also withdrawn in pursuance of our order dated 06.01.2021. In the meantime, on 10.03.2021 one resolution applicant i.e., Ajita Sil-Chem



Pvt. Ltd. expressed its interest to file resolution plan which was received on 06.04.2021 and the same was forwarded by RP to COC on 09.04.2021. The COC approved this resolution plan with 71.29% votes on 07.06.2021. In the meanwhile, communications with unsuccessful resolution applicant who had challenged the eligibility of earlier resolution plan also happened, however, their resolution plan was ultimately rejected and EMD was refunded. In this factual background, the RP has filed this application whereby he is seeking exclusion for total period of 606 days from CIRP period which comprises of the following:

- I. 10 days consumed in filing of application for approval of resolution plan (from 11.10.2019 to 21.10.2019);
- II. 504 days consumed in litigation regarding the eligibility
   of the resolution applicant ( from 21.10.2019 till 06.01.2021);
- III. 92 days for approval of new resolution plan approved by COC (from 08.03.2021 to 07.06.2021).
- Learned Counsel for the applicant appeared and prayed that period consumed in litigation was to be excluded from the CIRP period particularly when there was a feasible and viable





plan to resolve the insolvency of the Corporate Debtor. For this proposition, he has placed reliance on the following decisions:



- 4. Learned Senior Counsel Mr. Navin Pahwa on behalf of unsuccessful resolution applicant, i.e., M/s. Thirdeye Tradelink Pvt. Ltd. whose plan has again been rejected, appeared and submitted that firstly exclusion application needs to be disposed of. At this point of time, this Bench observed that it had no locus and having regard to the current views expressed by the Standing Committee of Finance of Parliament as well as higher Judicial Forums that frivolous litigation be discouraged. Learned Senior Counsel could not effectively controvert this query of the Bench.
- 5. We have considered the submissions made on behalf of the applicant-RP as well as material on record. It is not in dispute that this case got a history of litigation which has, in fact, delayed insolvency resolution of the Corporate Debtor. It



is also not in dispute that on 06.01.2021, this Adjudicating Authority directed the Resolution Professional and COC to reconsider the issue of eligibility of original resolution applicant as well as to consider the resolution plan filed by the unsuccessful resolution applicant, if revised. It is also not in dispute that both these plans were rejected and, therefore, IA/115(AHM)2021 was dismissed and disposed of whereby the applicant had prayed for some exclusion as on that date there were no plans under consideration of COC. However, subsequently, one resolution plan has come and which has been approved by COC with 71.29% votes. The application for approval of resolution plan is pending before this Adjudicating Authority. As a matter of fact, much time has passed and all timelines have been breached. Therefore, in normal circumstances, a liquidation order should be passed but having regard to the preamble and object of IBC, 2016, we would prefer resolution over liquidation in case as such resolution is proximate and really possible. Even, the Hon'ble Supreme Court in the case of Committee of Creditors of Essar Steel India Limited vs. Satish Kumar Gupta reported in 2019 SCC OnLine SC 1478 in para 108 held as under:



"108. Both these judgments have been followed in Neeraj Kumar Sainy v. State of Uttar Pradesh (2017) 14 SCC 136 at paragraphs 29 and 32. Given the fact that the time taken in legal proceedings cannot possibly harm a litigant if the Tribunal itself cannot take up the litigant's case within the requisite period for no fault of the litigant, a provision which mandatorily requires the CIRP to end by a certain date - without any exception thereto - may well be an excessive interference with a litigant's fundamental right to nonarbitrary treatment under Article 14 and an excessive, arbitrary and therefore unreasonable restriction on a litigant's fundamental right to carry on business under Article 19(1)(g) of the Constitution of India. This being the case, we would ordinarily have struck down the provision in its entirety. However, that would then throw the baby out with the bath water, inasmuch as the time taken in legal proceedings is certainly an important factor which causes delay, and which has made previous statutory experiments fail as we have seen from Madras Petrochem (supra). Thus, while leaving the provision otherwise intact, we strike down the word "mandatorily" as being manifestly arbitrary under Article 14 of the Constitution of India and as being an excessive and unreasonable restriction on the litigant's right to carry on business under Article 19(1)(g) of the Constitution. The effect of this declaration is that ordinarily the time taken in relation to the corporate resolution process of the corporate debtor must be completed within the outer limit of 330 days from the insolvency commencement date, including extensions and the time taken in legal proceedings. However, on the facts of a given case, if it can be shown to the Adjudicating Authority and/or Appellate Tribunal under the Code that only a short period is left for completion of the insolvency resolution process beyond 330 days, and that it would be in the interest of all stakeholders that the corporate debtor be put back on its feet instead of being sent into liquidation and that the time taken in legal proceedings is largely due to factors owing to which the fault cannot be ascribed to the litigants before the Adjudicating Authority and/or Appellate Tribunal, the delay or a large part thereof being attributable to the tardy process of the Adjudicating Authority and/or the Appellate Tribunal itself, it may be open in such cases for the Adjudicating Authority and/or Appellate Tribunal to extend time beyond 330 days. Likewise, even under the newly added proviso to Section 12, if by reason of all the aforesaid factors the grace period of 90 days from the date of commencement of the Amending Act of 2019 is exceeded, there again a discretion



can be exercised by the Adjudicating Authority and/or Appellate Tribunal to further extend time keeping the aforesaid parameters in mind. It is only in such exceptional cases that time can be extended, the general rule being that 330 days is the outer limit within which resolution of the stressed assets of the corporate debtor must take place beyond which the corporate debtor is to be driven into liquidation."

- by Hon'ble Supreme Court, we are of the view that CIRP period needs to be extended by way of exclusion for the period consumed in litigation and other processes. Other judicial decisions relied on by the applicant also support the cause of the applicant. Hence, we exclude 606 days from CIRP period, as prayed in this application. Accordingly, this application is allowed and stands disposed of in terms indicated above.
- 7. Urgent certified copy of this order, if applied for, be issued upon compliance with all requisite formalities.

1. The instant joint application is filed by the Applicant Companies under Section

230 to 232 of the Companies Act, 2013 (hereinafter referred to as 'the Act')

read with Companies (Compromise, Arrangement and Amalgamations) Rules, 2016 (hereinafter referred to as 'the rules') seeking directions for dispensation of meetings of Equity Shareholders of all the Applicant Companies for approving the Scheme of Arrangement. The Applicant Companies further prayed for dispensation of meetings of Creditors (secured and unsecured) of all the Applicant Companies as there are no secured and unsecured creditors in all the Applicant Companies.

- 2. The registered office of all the Applicant Companies are situated in the State of Gujarat, hence, falls within the jurisdiction of this Tribunal.
- 3. It is submitted that the Board of Directors of all the Applicant Companies have approved the Scheme of Amalgamation vide Board Resolution dated 20<sup>th</sup> February, 2021 passed in their respective Board Meeting and copies of the Board Resolutions are annexed to the application.
- 4. It is stated in the Auditors Report that the accounting treatment specified in the Scheme of Amalgamation is in conformity with the Accounting Standards as prescribed by the Central Government in terms of Section 133 of the Companies Act, 2013.
- 5. It is further stated that there are no investigation or proceedings under the Companies Act, 1956/Companies Act, 2013 have been instituted or are pending in relation to the Applicant Companies.
- 6. Learned PCS for the Applicant Companies further submitted that Competition Act, 2002 are not applicable in the present scheme as both the companies do



not meet the threshold limit as prescribed under the Competition Act, 2002. It is further submitted that the RBI rules are not applicable to both these Applicant Companies, hence, it is not necessary to serve notice to the Reserve Bank of India.

- 7. It is submitted that the applicant companies have following Shareholders;
  - I. The Applicant Company No. 1 having 14 equity shareholders. All the equity shareholders have given their consent affidavit for the proposed scheme of amalgamation. There are no secured and unsecured creditors in the Applicant Company No. 1 hence meetings of secured and unsecured creditors are not required to be convened with.
  - II. The Applicant Company No. 2 having 12 equity shareholders. All the equity shareholders have given their consent affidavit for the proposed scheme of amalgamation. There are no secured and unsecured creditors in the Applicant Company No. 2 hence meetings of secured and unsecured creditors are not required to be convened with.
  - III. The Applicant Company No. 3 having 7 equity shareholders. All the equity shareholders have given their consent affidavit for the proposed scheme of amalgamation. There are no secured and unsecured creditors in the Applicant Company No. 3 hence meetings of secured and unsecured creditors are not required to be convened with.
- 8. The Ld. PCS of the Applicant Companies appeared and submitted that meetings of all the equity shareholders be dispensed with as all the equity shareholders have given their consent for the proposed scheme of amalgamation. Since, there are no secured and unsecured creditors in all the Applicant Companies, meetings of secured and unsecured creditors are not required to be convened with.
- 9. We heard Mr. Dhiren Dave, Learned PCS on behalf of the Applicant Companies and considered the consent affidavits filed on behalf of the Shareholders of all the Applicant Companies for approving the proposed company Scheme of Amalgamation and documents on records waving their



right to participate in such meeting. Hence, meetings of the Shareholders of all the Applicant Companies are hereby dispensed with.

- 10. In this application, Applicants Companies have prayed for the following reliefs:
  - 1. Dispensing with requirement for convening the meeting of the Equity Shareholders of all the Applicant Companies as consent affidavits of all Shareholders of Applicants has been submitted and as there is no secured and unsecured creditor in all Applicant Companies, hence, the meeting of Secured and unsecured Creditor of all the Applicant Companies also be dispended with.
  - 2. Issuing direction for permitting the filing of application, petition, other documents as may be required for the purpose of sanctioning the proposed Scheme of Amalgamation of M/s. Antra Impex Private Limited and M/s. Art Bazar Fashions Private Limited with M/s. Lokesh Tex Trade Private Limited.
- 11. Having considered the entire material on record, this Tribunal passes the following order: -
  - (1) A meeting of Equity Shareholders of the Applicant Companies shall be dispensed as all Shareholders have no objection for dispensation of meeting and gave their consent affidavit for the Scheme of Amalgamation. Since, there are no creditors (Secured/unsecured) in the applicant companies, hence, there are no need to convene meeting(s) of the creditors of the Applicant Companies.
  - (2) Further, the Applicants Companies shall send a notice under Subsection (5) of Section 230 along with disclosure mentioned under Rule



6 of the Companies (CAA) rules, 2016 in Form No. CAA.3 to (i) The Central Government through the Regional Director, North Western Region, (ii) the Registrar of Companies (Ahmedabad) (iii) the Income Tax Authorities and (iv) the Official Liquidator stating that representation, if any, to be made by them shall be made within a period of 30 days from the date of receipt of such notice, failing which it shall be presumed that they have no objection to make on the proposed scheme. The said notice shall be sent forthwith by registered post or by speed post or by courier or by hand delivery at the office of the authority as required by sub-rule (2) of rule 8 of the Companies (CAA) Rules, 2016. 
### PER BENCH

- 1. The Applicant Companies have filed this joint application under Sections 230 to 232 and other applicable provisions of the Companies Act, 2013 (hereinafter referred to as the "Act") seeking directions for dispensing the meetings of equity shareholders of Applicant transferor company as all the equity shareholders of Applicant transferee company have given their consent for the proposed scheme of amalgamation and there are no secured and unsecured creditors in the aforesaid company, hence, the Applicant for companies prayed for dispensation of meeting of secured and unsecured creditors of Applicant transferor company. The Applicant company has further prayed for direction for holding and convening the meetings of shareholders and unsecured creditors of Applicant transferee company as there are no secured creditor in Applicant transferee company, hence, meeting of secured creditors of Applicant transferee company is not required to be hold and convened with, for the proposed scheme of amalgamation of Darshak Finstock Private Limited, transferor company and Madhu Silica Private Limited, transferee company alongwith its shareholders and creditors.
- 2. The authorized share capital of transferor company is Rs.20,00,000/- divided into Rs.20,000/- of Rs.100/- each. The transferor company is a Private Limited Company. The issued, subscribed and paid up share capital of the

transferor company is Rs. 20,00,000/ divided into Rs. 20,000/- equity shares of Rs. 100/- each. The Board of Directors of the transferor company *vide* resolution dated 1<sup>st</sup> February 2021, have approved the Scheme of Amalgamation.

- 3. The authorized share capital of transferee company is Rs.10,00,00,000/- divided into Rs.10,00,000/- of Rs.100/- each. The transferee company is a Private Limited Company. The issued, subscribed and paid up share capital of the transferee Company is Rs. 9,18,34,400/- divided into Rs.9,18,344/- of Rs.100/- each. The Board of Directors of the transferee Company *vide* resolution dated 1st February 2021, have approved the Scheme of Amalgamation.
- 4. Both of the Applicant companies are registered under the Registrar of Companies (ROC), Ahmedabad, hence, falls under the jurisdiction of this Tribunal.
- 5. It is stated in the Application that there are no proceedings or investigations pending against any of the Applicant Companies under sections 210-217, 219, 220, 223 to 227 of the Companies Act, 2013 and/or under sections 235 to 251 of the Companies Act, 1956. There are no winding up proceedings or any proceedings under Insolvency and Bankruptcy Code pending against any of the Applicant Companies. The Applicant Transferee Company has filed the Certificate of the Statutory Auditor confirming the



compliance with the Accounting Standards is produced at Annexure-H (Pg.225/226) to the Application.

- 6. Learned Counsel for the Applicant companies has submitted that the certificate of statutory auditor has been issued vide letter dated 08.07.2021 for the following the accounting treatment as prescribed under Section 133 of the Companies Act, 2013 which is annexed at Annexure-H. It is also submitted that the Valuation Report for the proposed Entitlement Ratio of Equity Shares, being just and reasonable has been provided by Mr. Krunal Sheth, a Registered Valuer.
- 7. Learned Counsel for the Applicant companies further submitted that Competition Act, 2002 are not applicable in the present scheme as both the companies do not meet the threshold limit as prescribed under the Competition Act, 2002. It is further submitted that the RBI rules are not applicable to both these Applicant companies, hence, it is not necessary to serve notice to the Reserve Bank of India.
- 8. Learned Counsel for the Applicant has submitted that following are the details of shareholders and creditors of both Applicant companies:
  - (i) The Applicant transferor company having 4 equity shareholders and all the equity shareholders of the transferor company have given their written consent

- on affidavit for approving of proposed scheme of amalgamation.
- (ii) It is also submitted that in Applicant transferor company, there are no creditors (secured / unsecured), hence, meeting of secured as well as unsecured creditor of Applicant transferor company is not required to be hold and convened.
- (iii) There are 12 equity shareholders in Applicant transferee company and 458 unsecured creditors as on 31.04.2021. The Applicant companies prayed from this tribunal for direction for holding and convening the meetings of aforesaid shareholders and unsecured creditors of transferee company.
- (iv) There are no secured creditor in Applicant transferee company, hence, meeting of secured creditor is not required to be held and convened with.
- 9. It is submitted that both these companies belong to the same group of management. The rationale for the proposed Scheme is set out below:
  - (i) Simplification of group structure by eliminating multiple companies thus enabling focus on core competencies and unlocking of value.
  - (ii) Greater efficiency in cash management of the amalgamated entity, and unfettered access to cash flow generated by the combined business which can be



- deployed more efficiently to fund organic and inorganic growth opportunities, to maximize shareholder value.
- (iii) Cost savings are expected to flow from more focused operational efforts, rationalization, standardization and of business processes, productivity simplification procurement, usage improved improvements, resource. human pool like resource common administration, finance, accounts, legal, technology and other related functions, leading to elimination of duplication and rationalization administrative of expenses.
- (iv) Healthier and larger balance sheet of both entities is expected to improve the credit profile, thereby enhancing the competitive positioning.
- (v) The Scheme will help amalgamated entity in sharpening its competitiveness and developing its core competencies, in the long term, through cost savings and benefit of economies of scale. It would result in greater integration, greater financial strength and flexibility of the amalgamated entity which will improve the competitive position of the combined entity.

The proposed amalgamation is in the interest of the shareholders, creditors, employees and other stakeholders in both of the companies.

10. The following are the reliefs prayed by the Applicant Companies.

- (A) THAT meeting of the Equity Shareholders of Darshak Finstock Private Limited, the Applicant Transferor Company be dispensed with;
- (B) THAT there are no secured creditors as well as unsecured creditors in Applicant transferor company, meeting of aforesaid creditor is not required.
- (C) THAT separate meetings of the Equity Shareholders and Unsecured Creditors of Madhu Silica Private Limited, the Applicant Transferee Company be directed to be convened through Video Conferencing or other Audio-Visual Modes, to obtain the approval to the Scheme;
- (D) That meeting of the Secured Creditors of Madhu Silica Private Limited, the Applicant Transferee Company is not necessary as there are no secured creditors in the applicant transferee company.
- 11. Having perused the entire material on record, and the submissions made during hearing, this Tribunal passes the following order;
  - A meeting of the Equity Shareholders of Darshak Finstock Private Limited, the Applicant Transferor Company is hereby dispensed with.
  - ii. Meetings of the Secured and Unsecured creditors of Darshak Finstock Private Limited, the Applicant



- Transferor Company are not necessary as there are no creditors in the Applicant transferor company.
- iii. Separate meetings of the Equity Shareholders and Unsecured Creditors of Madhu Silica Private Limited, the Applicant Transferee Company shall be convened and held on Friday, 12th day of November 2021 respectively at 11.00 a.m. and 3.00 p.m. for the purpose of considering and, if thought fit, approving the proposed Scheme of Amalgamation, with or without modifications;
- iv. In view of the current pandemic situation, all the meetings of shareholders and Unsecured creditors of Madhu Silica Private Limited, the Applicant Transferee Company may be convened and conducted through video conferencing or other Audio Visual Means. The Applicant Transferee Company shall appoint a Depository and other required agencies to facilitate the conduct of the meetings.
- v. The Applicant Company is directed to carry out voting through (i) remote e voting as well as (ii) e voting at the time of meeting for all the Equity Shareholders as well as unsecured creditors.
- vi. At least one month before the date of the meetings, a notice in Form No. CAA 2 convening the said meetings indicating the day, date, and time as aforesaid; alongwith instructions with regard to remote e-voting, together with a copy of the Scheme of Amalgamation, copy of the Explanatory Statement required to be sent



under Section 102 of the Act, read with Sections 230 and 232 of the Act and Rule 6 of the Companies (CAA) Rules, 2016 shall be sent to each of the Equity Shareholders and Unsecured Creditors of the Applicant Transferee Company; either through e mail or courier or speed post or registered post. In case of the Equity Shareholders, and Unsecured Creditors of the Applicant Transferee company, the notices shall be sent in reference to the list of the persons appearing on record of the Applicant Company as on 15th September, 2021.

- vii. It is hereby clarified that voting through Proxy shall not be permitted. However, voting through Authorised Representative is permitted.

It is further directed that at a meeting, majority of persons representing three-fourth in value of the equity shareholding and unsecured debt (present & voting in person or through authorized representative) should agree to the proposed Scheme.

Shareholders, or the value of the vote of each Equity Shareholders, or the value of debt of the Unsecured Creditors of the Company, as the case may be, shall be in accordance with the register or records of the Applicant Transferee Company for Equity Shareholders and as per the entries in the books of accounts of the companies for the Unsecured Creditors as on the date of the meetings; and where the entries in the records are disputed, the Chairman of the meetings shall determine the value for the purposes of the meetings.

xiv. The Chairman shall file an affidavit not less than 7(seven) days before the date fixed for the holding of

the meetings and to report to this Tribunal that the directions regarding issuance of notices and advertisement of the meetings have been duly complied with as per Rule 12 of the Companies (CAA) Rules, 2016.

xv. It is further ordered that the Chairman shall report to this Tribunal on the result of the said meetings in Form No CAA 4, verified by his affidavit, as per Rule 14 of the Companies (CAA) Rules, 2016 within 30 (Thirty) days of the conclusion of the last of the meetings.

xvi. In compliance of sub-section (5) of Section 230 of the Act and Rule 8 of the Companies (CAA) Rules, the Applicant Companies shall send a Notice of meeting in Form No. CAA 3 with a copy of the Scheme of Amalgamation, the Explanatory Statement and the disclosures mentioned under Rule 6 to (1) Central Government through the Regional Director, North Western Region, (2) the Registrar of Companies, Gujarat; and (3) the Income Tax Authorities, and (4) the Office of the Official Liquidator only for the stating that Company; Transferor Applicant representations, if any, to be made by them shall be made within a period of 30 (Thirty) days from the date of receipt of such notice, failing which it will be deemed that they have no objection to make on the proposed Scheme of Amalgamation. The said notices shall be sent forthwith after the notice for the

**Equity** meetings to the concerned are sent and of Shareholders Unsecured creditors the Applicant Transferee Company, either by Registered Post or by Speed Post or by Courier or by Hand Delivery at the offices of the authorities as required by sub-rule (2) of Rule 8 of the Companies (CAA) Rules, 2016. The aforesaid authorities, who desire to make any representation under sub-section (5) of Section 230 shall send the same to this Tribunal with a copy of the same to be supplied to the Applicant Company.

12. This C.A.(CAA) 61 of 2021 is disposed of accordingly.
