Since common reliefs are sought in all these applications, they are disposed

of with this common order.

2. All the above Applications have been filed under Sections 60(5), 25 and 47

of Insolvency and Bankruptcy Code 2016 [hereinafter referred to as 'I&B

Code,2016'] seeking the following reliefs:

- I. To direct the Resolution Professional to Disburse the amount pertaining to Pension, Gratuity and Provident Fund along with statutory interest, till the date of actual payment, to the Applicants.
- II. To direct the Resolution Professional to include the admitted amount of gratuity and the statutory interest thereon in the Information Memorandum prepared under S. 29 IBC;
- III. To direct the Resolution Professional to keep in abeyance the selection of Resolution Plan, until the claims of the applicants are admitted and included in the Information Memorandum;
- IV. To call for records to determine the accuracy of the Liquidation Assets as valued by the Registered Valuers.
- V. To direct the Resolution Professional to include the listed properties as in Table A to the Liquidation Asset, collate the value and update the Information Memorandum;
- VI. To declare the transactions carried out of the Managing Director as undervalued transactions as u/s. 47 of the I & B Code;
- VII. To restore the position as it existed before such undervalued transactions and reverse the effects thereof as u/s. 47 of the I & B Code.
- 3. The facts in brief are that the application TIBA/03/KOB/2020 filed by M/s.

RBL Bank Limited (hereinafter called as the Financial Creditor) against M/s.

Hindustan Newsprint Limited (hereinafter called as the Corporate Debtor) has

been admitted by this Tribunal vide order dated 28.11.2019.

4. The applicants submitted their claims before the Resolution Professional in Form D within the prescribed time. However, the Resolution professional bifurcated the Annexure A1 order of the Controlling Authority under payment of Gratuity Act 1972 and admitted the gratuity amount but unjustly rejected the interest component on the said Gratuity amount. The Applicants stated that the Resolution Professional has no authority to reject the statutory benefit accrued to the applicants when such claim was admitted by the Company, since no appeal against Annexure -A1 was filed by the Company against the order of the Regional Labour Commissioner (Central) and Controlling Authority under the Payment of Gratuity Act, 1972, Trivandrum directing the Corporate Debtor to pay gratuity amount along with an interest of 10% for delay in payment. 5. The applicants stated that representations were made before the Resolution Professional seeking entitlement of their claims on pension, provident fund and gratuity, which does not form a part of the Liquidation Estate under Section 36(4)(a) (iii) of I&B Code,2016.

6. It is further stated that the Resolution Applicant, M/s. KINFRA has come up with a Resolution Plan for 225 crores, whereas the valuation determined by the Resolution Professional is at $\gtrless600$ crores. The applicants' contention is that, when all the assets are not included to the liquidation assets, the aggregate liquidation value will be at a diminished value.

7. The Resolution Professional filed a reply to the applications stating that on 28.11.2019 this Tribunal declared moratorium under Section 14 of the Insolvency and Bankruptcy Code, 2016 prohibiting the institution and continuation of any proceedings against the Corporate Debtor by any court of law, Tribunal or by any authority. Hence, Resolution Professional is not authorized to deal with any of the assets of the Corporate Debtor. Hence, claim of any person shall be governed under the provisions of the IBC and any distribution under IBC shall be made in accordance with the Resolution Plan, if any, approved by this Tribunal under Section 31 of the IBC or under Section 53 of the IBC in the event of liquidation.

8. It is further stated that the reliefs sought by the Applicants are to admit their claim on interest on gratuity. The Resolution Professional has already admitted the interest on gratuity of all eligible claimants including the Applicants up to the insolvency commencement date. Further, it is stated that the Resolution Professional has already included the said admitted claim in the Information Memorandum. it is further stated that as per Regulation 13 of IBBI CIRP Regulation 2016, Resolution Professional shall verify and admit the claim as on the date of Commencement of CIRP.

10. Corporate Debtor is a public sector undertaking and have records of all the

assets of the Company, which also reflects in the financial statements and assets

register of the Corporate Debtor. The records pertaining to the valuation are confidential in nature, which cannot be disclosed to any other person other than members of the Committee, who have executed and undertaking to the Resolution Professional under the provisions of IBC.

11. The Applicants filed Rejoinder stating that the Resolution Professional has accepted and admitted the claims for gratuity along with statutory interest. Normally, the aforesaid decision should suffice for the claim submitted by the applicants, but he has restricted the statutory interest on gratuity till the date of commencement of CIRP on 28.11.2019. The Resolution Professional in paragraphs 3 & 4 allege that the Annexure. A -1 order passed by the Regional Joint Labour Commissioner after the insolvency commencement date is not binding on the Resolution Professional and is violative of the provision of moratorium.

12. In the rejoinder filed in MA/183/KOB/2020 and MA/185/KOB/2020 the applicants have raised their claims pertaining to the outstanding dues arising out of the contracts entered into with the Corporate Debtor Company and the landed assets, which are genuine concerns of the applicants during the pendency of the CIRP. Additionally, the applicants apprehended that if the landed assets are not included to the liquidation assets of the Corporate Debtor, the interests of the applicants would get affected consequently. It is also stated that the Resolution Professional has wrongfully rejected the claims of the Applicants and defaulted in including the landed assets listed in the above application. Hence, the intention of the applicants is only to

include their claims & benefits for which the applicants are rightfully eligible by the terms of the contract.

13. It is also stated that during the pendency of the above applications, the Resolution Plan was approved by this Tribunal vide order dated 29.01.2021 in IA (IBC)/21/KOB/2021. On perusal of the Resolution Plan, it is understood that the averments stated by the Resolution Professional in paragraphs 8, 9 & 10 of the Counter is a wrong statement. The Resolution Plan states that the 282 hectors approx. of landed assets was acquired and transferred to M/s. Hindustan Paper Corporation Ltd. vide an agreement with Governor of Kerala. It further states, being in violation of the said Agreement the District Collector has issued notice dated 08.11.2019 for resumption of the land before commencement of the CIRP.

FINDINGS

14. This Tribunal heard the arguments advanced by the Learned Counsel for the applicants and Resolution Professional, and had gone through all the materials placed on record.

15. With regard to prayer No.1 to direct the Resolution Professional to disburse the amount pertaining to Pension, Gratuity and Provident Fund along with statutory interest till the date of actual payment to the Applicants and Prayer No.2 to direct the Resolution Professional to include the admitted amount of gratuity and the statutory interest thereon in the Information Memorandum prepared under Section 29 of I&B Code, since the Resolution Professional has stated that he has admitted the interest on gratuity of all eligible claimants till the Corporate Insolvency Resolution Process commencement date i.e. on 28.11.2019 and already included the admitted claims in the Information Memorandum, nothing survives for further consideration in this application on the above prayers.

16. Since this Tribunal has already approved the Resolution Plan vide order dated 29.01.2021 in IA (IBC)/21/KOB/2021, any of the other prayers sought for applicants cannot be granted by this Tribunal at this belated stage.

17. In view of the aforesaid discussions, nothing survives for further consideration in these M.As/I.As. Hence all the aforesaid **Applications are dismissed**, noting the submissions of the learned Resolution Professional with regard to payment of pension, gratuity and provident fund along with statutory interest thereon till the date of commencement of CIRP i.e. on 28.11.2019.
