11 MA/181/KOB/2020 IN IA/166/KOB/2020 IN MA/01(KOB)/2020 IN IBA/145/2019(CB)

None has appeared for the Applicant. Learned counsel for the Respondent Shri Maulik Nanavati appeared through VC. This application is filed under Rule 11 of the NCLT Rules, 2016 for restoration of IA/166/KOB/2020 in MA/01/KOB/2020 in IBA/145/2019(CB). It appears from records that IA/166/KOB/2020 was dismissed on 03.11.2020 as "not pressed". The applicant has stated in this MA that the counsel is hopeful that the parties might arrive at an out of court settlement. However, the applicant submitted that he would be greatly prejudiced if the said IA is not restored, in the event of settlement talks resulting in a failure.

The learned counsel for the Respondent submitted that settlement talks have already been started and an amount of Rupees one lakh has been paid by the CD on 23.12.2012

I have heard and perused the records. **The MA/181/KOB/2020 for restoring the IA/166/KOB/2020 is allowed.** However, the prayer of the applicant to keep the said IA/166/KOB/2020 in abeyance cannot be considered at this time.

12 MA/01(KOB)/2020 IN IBA/145/2019(CB)

None has appeared for the Respondent. Learned counsel for the Applicant Shri Maulik Nanavati appeared through VC. He submitted that settlement talks have already been started and an amount of Rupees one lakh has been paid by the CD on 23.12.2012. According to Shri Maulik, the parties may be able to settle the dispute before the next date fixed. However, the bench observed that this is a long pending case and hence requires early disposal. The parties may bear in mind that there shall be no further adjournment in this case. List on 12.02.2021 for final hearing. Registry is directed to issue copy of this order to both the parties through email.

13 IA/205/KOB/2020 IN IBA/35/KOB/2019

Learned IRP Shri Sathiq Buhari appeared through VC. This is an application filed by the Interim Resolution Professional under Section 33(2) of IBC, 2016 seeking liquidation of the Corporate Debtor.

Vide our order dated 4th December 2020 the IRP was directed to file an affidavit explaining why he has not complied the Regulation 36A of the IBBI (insolvency Resolution Process for Corporate Persons) Regulations, 2016 in this CIRP Proceedings. He was also directed to explain the delay in filing this IA. In addition to the above, the IRP was also directed to report to this Tribunal the status of the Writ Petition filed by the CD before the Hon'ble High Court of Kerala.

In response to the above order, the IRP filed an affidavit on 14.12.2020. The IRP in his affidavit submitted that the Order passed on 21.10.2020 in IA No.160/2020 specifically directed the IRP to complete the CIR Process on or before 30.11.2020. So, in the 1st CoC meeting convened on 18.11.2020 an agenda was placed before the CoC seeking permission to extend CIRP time under Section 12(2) of IBC, 2016. But in view of the non-co-operation and resistance of suspended directors, the matter was placed before the 2nd CoC meeting convened on 23.11.2020. The 2nd CoC meeting by 100% vote took a decision for liquidation and directed the IRP to file liquidation application under Section 33(2) of IBC, 2016 on or before 30.11.2020. As such the liquidation application (IA/205/KOB/2020) was prepared on 26.11.2020 but could file it on 1.12.2020 because of the reason that 28.11.2020, 29.11.2020 and 30.11.2020 were declared holidays for this Tribunal. Hence, the IRP submitted that there is no delay in submitting the liquidation application before this Tribunal.

The IRP further submitted that the suspended Directors of CD filed WP(C)No.24637/2020 before the Hon'ble High Court of Kerala challenging the CIRP in IBA/35/KOB/2019 but it was dismissed on 4.12.2020 for the reason that Writ Petition became infructuous in view of filing of liquidation application before this Tribunal.

The learned IRP submitted that he will produce the order of the Hon'ble High Court of Kerala in WP(C) No.24637/2020 today itself. He may do so.

I have heard the IRP and perused the whole case records. Reserved for orders. **List** for pronouncement of orders on 11.01.2021.

14 IBA/30/KOB/2020

Learned counsel for the Operational Creditor Ms Sudhakshina Prasad appeared through VC. None has appeared for the Corporate Debtor M/s. Seguro Foundations and Structures Pvt Limited. Ms Jagrithi Sanghi appeared for the Additional Corporate Debtor M/s. INKEL and submitted that her client has received only the mail sent from this Tribunal dated 26.11.2020 and the copy of IBA application has not yet been served on them by the Operational Creditor. The OC is directed to
