#### 1 CP(IB)/8/KOB/2021

Learned counsel for the Financial Creditor Shri A. Sunil Shankar appeared through VC. This is an application filed by the FC M/s. Federal Bank against the CD M/s. Foodco Delicacies India Pvt Ltd under Section 7 of IBC 2016 for recovery of total debt amount of Rs.11,08,25,240.20.

Due to power failure and network disturbances, this file could not be transmitted from the Registry to the Hon'ble Member (T), who is stationed at Mumbai.
