Learned counsel for the Applicant/Liquidator Smt Midhuna KC as well as learned counsel for the erstwhile directors of CD Shri Akhil Suresh appeared through VC. This MA is filed by the liquidator under Regulation 9 of the IBBI (Liquidation Process) Regulations, 2016 read with Section 60(5) of IBC, 2016 seeking certain directions to the erstwhile directors. It appears from records that Advocate Harikumar G Nair has appeared for the erstwhile directors through VC in the Proceedings of this Tribunal on 14.12.2020. Vide our order dated 14.12.2020 the erstwhile directors of CD were directed to file the counter within 2 weeks and Liquidator has to file the rejoinder on or before 11.01.2021. However, they have not filed their counter till date. The erstwhile directors of CD are hereby **given the last opportunity** to file their counter within a week, failing which it will be presumed that they are not interested to contest the case and the matter will be decided in accordance with the available records. **List on 16.02.2021 for hearing**.

16 IA/143/KOB/2020 IN TIBA/19/KOB/2019

Learned RP Shri Jasin Jose appeared through VC. The RP suggested the name of Shri Kizhakkekara Kuriakose Jose, Insolvency Professional as authorised representative for the Home Buyers. This IA is filed by the Applicant/CD under section 12A of the IBC 2016 with the prayer to recall the order dated 22.04.2020 and to dismiss the original application filed by the Operational Creditor on the basis of settlement arrived between the parties and to stay all further proceedings in IBA/16/KOB/2020 on the file of this Tribunal. After hearing learned counsel for OC, CD and IRP this Tribunal vide order dated 21st September fixed the fee of IRP as Rs.90,000/- and directed the OC to file the Form FA through IRP on or before 30.09.2020. Even though the parties were repeatedly directed in the hearings on 30.09.2020, 15.10.2020, 10.11.2020 and 16.12.202 to settle the fee of the IRP, the learned counsel for the IRP submitted that the fee of IRP has not yet been settled till date. In spite of giving several opportunities the parties have also not yet filed the Form FA. Therefore, in view of non-filing of Form FA through IRP this IA/124/KOB/2020 IN IBA/16/KOB/2020 is dismissed.

As directed vide our order dated 22.04.2020 the Operational Creditor is directed to deposit a sum of Rs.2,00,000/- (Rupees two lakh only) with the IRP to meet the expenses towards issue of public notice and inviting claims within two days from the date of this order. The IRP may proceed with the Corporate Insolvency Resolution Process within three days from the date of this order. Registry is directed to issue a copy of this Order to the Registrar of Companies, Kerala for updating the Master Data of the Corporate Debtor, who shall send a compliance report in this regard to the Registry within seven days.

Registry is also directed to issue copy of this order to the OC, CD and IRP through email.

18 IA/125/KOB/2020 IN IBA/16/KOB/2020

Learned counsel for the Applicant/RP Shri Jasin Jose as well as learned counsel for the CD Shri Vino Jose appeared through VC. This IA is filed by the IRP under Section 12 A of the IBC, 2016. The learned counsel for the IRP on 21.09.2020 submitted that the OC as well as CD has communicated to him that they have settled the matter. But the parties have not taken steps to file the withdrawal application in Form FA through IRP. After hearing learned counsel for OC, CD and IRP this Tribunal vide order dated 21st September fixed the fee of IRP as Rs.90,000/- and directed the OC to file the Form FA through IRP on or before 30.09.2020. Even though the parties were repeatedly directed in the hearings on 30.09.2020, 15.10.2020, 10.11.2020 and 16.12.2020 to settle the fee of the IRP, the learned counsel for the IRP submitted that the fee of IRP has not been settled till date. In spite of giving several opportunities the parties have also not yet filed the Form FA.

Therefore, in view of non-filing of Form FA through IRP this IA/125/KOB/2020 IN IBA/16/KOB/2020 is dismissed.

As directed vide our order dated 22.04.2020 the Operational Creditor is directed to deposit a sum of Rs.2,00,000/- (Rupees two lakh only) with the IRP to meet the expenses towards issue of public notice and inviting claims within two days from the date of this order. The IRP may proceed with the Corporate Insolvency Resolution Process within three days from the date of this order as stipulated under IBC, 2016.

Registry is directed to issue a copy of this Order to the Registrar of Companies, Kerala for updating the Master Data of the Corporate Debtor, who shall send a compliance report in this regard to the Registry within seven days.

Registry is also directed to issue a copy of this order to OC, CD and IRP through email.

19 **IBA/32/KOB/2020**

Learned counsel for the Operational Creditor Shri Vinod PV as well as learned counsel for the Corporate Debtor Shri Paulose Abraham and Pranoy Harilal appeared through VC.
