ORDER

1. This Order has arisen upon the application filed by the Resolution Professional under Section 12(2) of IBC, 2016 seeking extension of the time period of Corporate

Insolvency Resolution Process of the Corporate Debtor for a further period of 90 days.

- 2. The Application for Corporate Insolvency Resolution Process filed by Shri Alex Thomas, Managing Director of M/s. Tierra Food India Private Limited (Corporate Debtor) against M/s. Kerala State Industrial Development Corporation Limited (KSIDC) (Financial Creditor) was admitted by this Tribunal vide order dated 3rd February 2021 in IBA/39/KOB/2020 wherein the applicant herein was appointed as Interim Resolution Professional. In the 1st meeting of Committee of Creditors held on 09.03.2021, the IRP was appointed as Resolution Professional.
- 3. Accordingly, the Resolution Professional is carrying on the CIR Process. The RP submitted that the 180 days period of the CIRP will be expiring on 08.08.2021.
- 4. The RP further submitted that almost 50 days was lost on account of complete lockdown. Only one bid was received and that too from the promoter, who qualifies for bidding the resolution of the Company as per Section 240A of IBC.
- Accordingly, the CoC resolved with 100% voting at its meeting held on 28th May 2021 to seek approval of extension of 90 days from this Tribunal ie., from 180 days to 270 days for conclusion of the CIRP Proceedings.
- 6. Hence the RP filed this IA seeking indulgence of this Tribunal to grant an extension of 90 days to enable him to complete the CIR process of the Corporate Debtor.
- 7. We have heard the learned Resolution Professional through video conferencing and also gone through the records including the Resolution passed by the CoC in its meeting held on 28.05.2021. In the minutes of CoC held on 28th May,2021 as

Agenda item No.4 the extension of time in CIRP due to the present lockdown was discussed and it was resolved with 100% voting right to seek approval of the Adjudicating Authority for extension of further period of 90 days beyond 180 days already taken in the matter. Section 12(2) of IBC states that "if the Resolution Professional files an application before the Adjudicating Authority for extension of the period of the CIURP beyond one hundred and eighty days by a resolution passed at a meeting of the committee of creditors by a vote of 66% of the voting share, if the Adjudicating Authority satisfies that the subject matter of the case is such that CIRP cannot be completed within one hundred and eighty days, it may by an order extend the duration of such process beyond one hundred and eighty days, but not exceeding ninety days."

8. In view of the aforesaid provision and considering the resolution passed by the CoC, this Tribunal finds that it is a fit case to grant the extension sought by the applicant/Resolution Profession. Hence this Tribunal allows the IA/IBC/104/KIOB/2021 granting further extension of 90 days from 8.8.2021. The Resolution Professional is directed to complete the CIRP on or before 06.11.2021. He is at liberty to complete the process before that date also.
