ROC in his report dated 23.07.2021 stated that the Regional Director being the competent authority vide letter dated 15.07.2021 has conveyed that on behalf of the Central Government has examined the scheme with reference to the material papers made available to him and accordingly decided not to make any objection to the above Scheme of Amalgamation except for a direction to the Transferee Company to comply with the provision of Section 232(3)(i) of the Companies Act, 2013 for merger of Authorized Share Capital of the Transferor with Transferee Company and also to file the amended MoA and AoA with the jurisdictional Registrar Companies.
