Shri Renjith Rajappan, Advocate appeared on behalf the counsel for appellant through VC. This is an Appeal filed by the Appellant for restoring the name of the Appellant Company in the Register of ROC. The documents submitted by the Appellant in his Appeal include the following:

Shri Renjith Rajappan submitted that the Appellant has not obtained the statutory permits and licenses which are required for commencing the operations of the Appellant Company.

The Appellant is directed to file an affidavit with regard to the status of statutory permits and licenses within a week. ROC has already filed his Report. Hence reserved for orders. List for pronouncement of orders on 10.02.2021.

3 IA(IBC)/27/KOB/2021 IN IBA/133/KOB/2019/CB

Learned counsel for the Liquidator Shri Vinod PV appeared through VC. This application is filed by the liquidator under Section 66 read with Section 60(5) of IBC, 2016 with the prayer to pass an order to declare that the entries of Rs.21.37 crore

made in the audited financial statement for the year 2018 described in Paragraphs 15 of the application are fraudulent transactions and to pass an order to declare that the Respondent Nos.1 to 3 are liable for the loss of Rs.21.37 crore suffered by the Corporate Debtor and direct the R1 to R3 to pay Rs.21.37 crores to the account of the Liquidator for distribution under Section 53 of the IBC, 2016.

I have heard and perused the records thoroughly. It appears that it would be justified to pass order on this application only after perusing the counter. The applicant is therefore directed to issue notice to Respondents 1 to 3 along with copy of this IA by Registered Post with A/D and submit proof of service (acknowledgement card or postal track record) with an affidavit before the next date fixed. Registry may also issue notice to Respondent Nos 1 to 3 through email. Respondents may file their counter within two weeks. **List on 02.03.2021**.

4 IA(IBC)/32/KOB/2021 IN MA/9/(KOB)/19 IN CP(IB)/689/17(CHENNAI BENCH)

Learned counsel for the applicant Shri Ramalingam VA as well as learned GP for R1, R2, R5, R6, R1, R13 and R14 Shri Mohammed Fazil MP appeared through VC. This is an application filed by the applicant for rectification of our order dated 06.11.2020 in MA/9/KOB/2019 in respect of paragraph 76, lines 4, 5 and 6 to the extent of stating that "the sole statutory creditor (R17 and 18 in MA 9/2019) ie. The Joint Director General of Foreign Trade and The Deputy Director General of Foreign Trade)".

I have heard the learned counsel for the applicant Shri Ramalingam and have also perused the case records. It is noted that in Page 11 para 32 of the Common Written submissions filed by the counsel on behalf of the Corporate Debtor, it is stated that "the sole statutory creditor (R24 and 25 in MA9/2019) who submitted his claim has been paid under the Resolution Plan".

Therefore, there was an error in the Common Written Submissions filed by the CD. Learned counsel for applicant stated that he shall file an application to rectify the mistake occurred in the written submission and sought an adjournment of this matter to another date. List the IA(IBC) on 01.03.2021, before that date the applicant may file the application for rectification.

5 **IBA/46/KOB/2019**

Both sides sought an adjournment through email. Today the case is posted for final hearing. This case is filed by the Financial Creditor M/s. Tata Global Beverages Ltd against the Corporate Debtor K/s. Kerala Ayurveda Limited under Section 7 of IBC, 2016 on 01.11.2019. Pleadings are complete. Meanwhile the respondents have raised the issue of referring the matter to the Arbitrator and also the maintainability of the IB Application, which have already been disposed of.

It appears that this is a very old case. However, the adjournment sought at this time is allowed. Since this is an IBC matter, the parties may bear in mind that this case

cannot be prolonged and hence there shall be no further adjournment in this case. In case the learned counsel for the parties are not cooperating for hearing, the case will be disposed of as per the available records and that no further adjournment will be granted.
