The Liquidator in his IA submitted that no bidders were available even in the four E-Auctions already been conducted. The amount proposed by the Liquidator in the 4<sup>th</sup> round of E-Auction was Rs.3.75 crores.

The Liquidator further submitted that M/s. Guardian Aviation Inc Registered in USA has submitted their EoI to acquire the Sea Plane through their Indian Subsidiary for Rs.3.00 crores. But they are not interested in E-Auction technical procedures and submitted the EOI to acquire through private sale Negotiation.

Heard the Liquidator and perused the records.

It is noted that E-Auctions conducted by the Liquidator were during the period between 26.08.2020 and 11.03.2021. The aforesaid period was totally under Covid pandemic lockdown resulting major constrain to get more buyers/bidders.

The Liquidator is therefore directed to conduct one more round of E-Auction immediately with wide global publicity so as to explore the possibility of getting prospective buyers.

With the above direction IA(IBC)/95/KOB/2021 IN TCP/59/KOB/2019 is disposed of
