The written consent in Form 2 as specified under Rule 9 of the Insolvency and Bankruptcy (Application to Adjudicating Authority) Rules, 2016 has also been filed by the IRP to continue as RP.

Accordingly, the IRP prayed before this Tribunal to pass orders for appointing him as Resolution Professional in this case.

After perusal of the case records including the Minutes of the 1st meeting of the Committee of Creditors, this Tribunal hereby appoints Shri K.Easwara Pillai, Interim Resolution Professional (IBBI/IPA-001/IP-P-004482017-2018/10791 as Resolution Professional in IBA/04/KOB/2020. He is directed to meticulously adhere to the Rules and Regulations issued by IBBI to conduct Corporate Insolvency Resolution Process from time to time.

IA(IBC)/20/KOB/2021 IN IBA/04/KOB/2020 Is allowed accordingly.

5 IA(IBC)/22/KOB/2021 IN IBA/23/KOB/201

Learned counsel for the Petitioner Shri S.Krishnamoorthy as well as learned PCS for R1 to R4 Shri Yogindunath appeared through VC. Counter has been filed by the Respondents. Learned counsel for the petitioner submitted that the petitioner has already invested Rs.64 lakhs in the R1 Company. The petitioner has alleged that the R1 Company and R2 to R4 have neither acquired the machinery nor accounted the loan given to the company. The petitioner has till date been issued shares worth Rs.1,00,000/- only and accordingly now holds 20% of the full paid up equity shares of the Company and is a director along with R2 to R4. He further stated that since he was permanently residing at Kolkata, the majority shareholders who are all based at Kerala, were acting in concert with each other have been continuously abusing their position in the Company and mismanaging the affairs of the Company keeping

the petitioner in the dark. In the counter the Respondents have not clearly explained the aforesaid allegations. Hence the learned counsel for the petitioner insisted to pass orders on interim prayer sought in the CP to direct an independent audit into the affairs and accounts of the Company so as to ascertain and report on the true financial position of the Company and extent of funds diverted or siphoned off by the Respondents 2 to 4.

Learned PCS for the respondents submitted that since the Company dealt with Food items, during Covid period, their business performance has become negative.

After perusal of the whole case records including hearing of both sides, I am of the view that the petitioner has made out a prima facie case against the Respondents to grant the interim relief prayed for, and hence intervention of this Tribunal is required at this point of time to meet the ends of justice. Accordingly, the interim prayer sought for by the petitioner to conduct an independent audit into the affairs and accounts of the R1 Company is allowed.

During the hearing, both the parties were directed to suggest the name of an Auditor to enable this Tribunal to entrust the task of conducting the auditing of the R1 Company. Accordingly, the counsel for the petitioner suggested the name of Shri Jobin George, Chartered Accountant. But no name has been suggested by the learned counsel for the respondents.

Accordingly, this Tribunal hereby appoints Shri Jobin George, FCA, M/s. John Moris & Company, Chartered Accountants, Door No.56/503, IInd Floor, Building No.G 308, Shan Apartment, Near Avenue Centre Hotel, Panampilly Nagar, Kochi 682 036 (Mobile 9995832342) to audit into the affairs and accounts of the R1 Company M/s. Venad Food Processing and Exports Private Limited, Registered Office: 48/2368/D, Alat House, Swamypadi Road, Elamakkara, Ernakulam, Kerala 682 026. The Auditor is directed to audit into the affairs and accounts of the Company and report on the true financial position of the Company and funds, if any, diverted or siphoned off by Respondents 2 to 4. The Auditor is directed to submit his report to this Tribunal with copy to both the parties on or before 26.02.2021. The fee of the Auditor will be borne by the Petitioner.

Since the Respondents have filed the counter, the petitioner may file his rejoinder before the next date fixed.

Registry is directed to issue copy of this order to the aforesaid Auditor and also to both the parties through email. **List on 03.03.2021**.
