According to Shri Arun Kumar he had complied all directions from the FC for settlement of the case and rescheduling of the balance amount. He also submitted that copy of the mail has also been sent to the learned counsel of FC.

Heard both sides. It appears from records that this IBA was filed on 05.02.2020, which shows that about one year has already been elapsed. In the name of settlement both the parties have taken adjournments on 17.07.2020, 28.08.2020, 14.10.2020, 19.11.2020, 15.12.2020 and 04.01.2021. Vide our order dated 04.01.2021 both the parties were informed that there shall be no further adjournment in this case. However, even today no settlement memo has been filed. Anyway, the CD has already been paid Rupees one crore to the FC. Therefore, FC is directed to complete the process without any further delay. It is expected that both the parties will co-operate for the early disposal of this case.

# List on 05.02.2021 before that date the parties may file their settlement memo, failing which law will take its own course.
