## 5 REPORT/16/KOB/2021 IN IA/26/KOB/2021 IN IBA/24/KOB/2020

Learned RP Shri Mohanan TS appeared through VC. This is a status report filed by the RP attaching the Minutes of the Second Meeting of the Committee of Creditors held on 09.02.2021. I have thoroughly perused the report. **The report is admitted and taken on record.** Registry is directed to place the report in the appropriate file.

#### 6 IA/01/2021 IN MA/05/KOB/2020 IN TIBA/1/KOB/2019

Learned Liquidator Shri Shawn Jeff Christopher appeared through VC. This is an IA filed by the liquidator with the prayer to direct the directors of the CD to file an affidavit before this Tribunal regarding the outstanding debts receivable in the name of the CD.

Vide order dated 04.02.2021 in this IA, the liquidator was directed to issue fresh notice with copy of this IA with all documents to the impleaded Respondent Nos 2 and 3, viz: Shri Reji Sivankutty and Shri Tinu Jose, and submit proof of service (A/d card or Postal Track Record) with an affidavit. In the very same order, the above impleaded R2 and R3 were also directed to file their counter in this IA within two weeks. Accordingly, the liquidator complied with the order and submitted the proof of service. But the R2 and R3 have neither taken steps to defend their case nor filed any counter.

The Learned Liquidator in this IA submitted that on commencement of the liquidation process, public announcement was made on 21.02.2020 and letters were sent to the Outstanding Debtors requesting remittance of the amount due to the Corporate Debtor. No response has been received by the liquidator till date. The Liquidator has significant hardship in identifying the number of outstanding debtors of the Corporate Debtor as there are inadequate disclosures in the audited financial statements of the Corporate Debtor.

The Liquidator submitted that on verification of the turnover of the corporate debtor, 'outstanding debtors' for the financial years 2015-2016 was Rs.8,21,760.95/-, 2016-2017 was Rs. 13,34,274.43/, 2017-2018 was Rs.18,81,508.42/. At the time of take over and as per the Information Memorandum, the suspended directors provided details of the total outstanding debtors along with breakup as Rs. 98,04,951.55/ (Sabkaa Payments Limited (Rs. 89,97,785/), Mobisoft Technology India Private Limited (3,40,320.38), Erixon Business Solutions Private Limited (2,18,923.88), GPR India Private Limited (1,01,306), Alive Teleservices Private Limited (67,661.88/-), Fusion India Project Management Private Limited (56,954.41/-), Airpegasus Private Limited (22,000/-)). However, no details or break-up to the balance of Rs. 18,81,508.42/-(i.e., balance dues from the 'outstanding debtors' according to the audited financial statement 31.03.2018 [financial year 2017-2018]) minus Rs. 8,07,166.55/-(i.e., balance dues from outstanding debtors (excluding invoice raised against Sabkaa Payments Limited for the financial year 2018-2019), as such invoice raised for the financial year 2018 2019, ought to have been reflected in the financial statement of 31.03.2019. Receivable as compared to the turnover was found significantly mismatching. Hence realisable 'outstanding debts' in favour of the Corporate Debtor are found divergent in comparison with the turnover and receivables to the Corporate Debtor.

According to the Liquidator, Sabkaa Payments Limited "Sabkaa" owes the Corporate Debtor Rs. 90,00,011.04/-. Sabkaa Payments Limited "Sabkaa" was registered as a Public Limited Company registered with Registrar of Companies, Delhi on 10.02.2016 vide CIN U72900DL2016PLC290846, having registered office of the company at LEVEL 15, EROS CORPORATE TOWERS, NEHRU PLACE, NEW DELHI New Delhi DL 110019. The directors of the company are, REJI TINU JOSE. ANIL ROY, REVATHYRADHAKRISHNAN. SIVANKUTTY, TheCorporate Debtor, 'Achariya', holds 65.99 % (32,998 equity shares of Rs. 50 each) shareholding in Sabkaa Payments Limited. As per the audited financials of Sabkaa Payments Limited for FY 2016-17, it had obtained loan of Rs.1,09,550/- from Achariya Techno Solutions (India) Private Limited. The flow of funds cannot be traced in absence of books of accounts of the Corporate Debtor 'Achariya'. During the year 2018-19, it was noticed that Achariya had rendered SMS-Server maintenance services to Sabkaa Payments on account amounting to Rs. 90,00.011.04 The payment for which is due and receivable for this service rendered amounts to Rs. 90,00,011.04. This amount is realisable to the Corporate Debtor. As per S. 2(87) of the Companies Act, 2013, Sabkaa Payments Limited "Sabkaa" is the subsidiary of the CorporateDebtor since control and composition of Sabkaa Payments Limited "Sabkaa is held and exercised by suspended directors of the Corporate Debtor and the Corporate Debtor holds control by more than one-half of the total voting power. As such, according to the Liquidator, the Corporate Debtor "Achariya" and Sabkaa Payments Limited "Sabkas" should be a related party

This IA is therefore filed by the Liquidator in order to have clarity and certainty in respect to the 'outstanding debtors' from the suspended directors.

I have heard the learned liquidator. After perusal of the whole case records, I am of the view that the reliefs sought by the liquidator are to be allowed in the interests of justice.

The Impleaded Respondent No.2 Shri Reji Sivankutty and Respondent No.3 Shri Tinu Jose are therefore directed file an affidavit before this Tribunal showing the outstanding debts receivable in the name of the Corporate Debtor with year wise break-up from financial years 2014-15, 2015-16, 2016-2017 and 2017-2018 along with the supporting documents and to explain in their affidavit the services rendered to Sabkaa Payments Limited in the name of the Corporate Debtor with year wise break up from Financial years 2016-2017, 2017-2018 and 2018-2019 within 7 days.

With the above direction IA/01/2021 IN MA/05/KOB/2020 IN TIBA/1/KOB/2019 is disposed of.

Registry is directed to issue copy of this Order to the respondents through email in addition to normal procedure.
