1 CAVEAT NO. 04/KOB/2021 IN TIBA/03/KOB/2019

Learned counsel for the Caveator Ms Jinnu Sara George appeared through VC. This Caveat is filed by a contractor of the Corporate Debtor Company who is also an applicant in MA/185/KOB/2020. Ms Jinnu Sara George submitted that the Resolution Plan submitted by the Resolution Applicant in this case is an undervalued plan. She also submitted that this Tribunal may ensure the payment with regard to PF and Gratuity while approving the Resolution Plan. She prayed that the Resolution Plan shall not be approved by this Tribunal without hearing the Caveator.

Learned counsel for the RP Shri PV VINOD submitted that the Resolution Plan contemplates payments related to PF and Gratuity. He also submitted that valuation of the property of the CD was done by the Registered Valuer.

The submission of the learned counsel for both the parties are recorded.

In view of the fact that the Caveator has been heard, this CAVEAT NO. 04/KOB/2021 IN TIBA/03/KOB/2019 is closed.

Learned counsel for the RP Shri PV VINOD submitted that the Resolution Plan contemplates payments related to PF and Gratuity. He also submitted that valuation of the property of the CD was done by the Registered Valuer.
