Learned RP Shri Jasin Jose appeared through VC.

This is an Appeal filed by the Appellant for restoring the name of the Appellant Company in the Register of ROC. The appellant is a shareholder of the R2 Company. It appears from records that the appellant has not furnished the following documents, which are necessarily required in the case of appeal filed under Section 252 of the Companies Act, 2013.

- (i) Master Data of the Company
- (ii) Memorandum of Association and Articles of Association of the Company
- (iii) Latest Income Tax Return acknowledgement of the Company
- (iv) Financial Statements for the defaulted periods.

The Appellant has also sought a direction restraining the alienation, encumbrance or transfer of possession of, or user of, the assets and properties of the Company, covered by Sale Deed Nos. 1328/2015, 1404/2015, 1500/2015, 1501/2015 and 1764/2015, Thiroorangadi SRO to anybody else and directing the office to communicate the same to the SRO, Thiroorangadi and the Village Office, Abdul Rehman Nagar Village, pending disposal of this Company Appeal.

Shri Rohit R. Shenoy requested the Bench to postpone the matter to tomorrow to enable his senior to submit the case. Allowed.

Learned PCS for the Applicant Companies Shri P.P.Zibi Jose appeared through VC.

Shri Zibi Jose submitted that he has filed the required documents as directed by this Tribunal vide order dated 8.04.2021.

#### 7 CA/54/KOB/2021 IN CP(COMPANIES ACT)/23/KOB/2021

Learned counsel for the Applicant Shri P.G.Jayashankar appeared through VC. This application has been filed for waiver of the requirements specified under clause (1) and (b) of Section 244 of the Companies Act, 2013, to apply under Section 241 of the Act and for producing the share certificates of the consenting parties.

Heard the learned counsel for the applicant. The applicant has filed a statement showing the details of the shares and their percentage. The applicant and the consenting parties have 21.49% of shares. Considering the materials on record, I think it would be justified to allow the relief sought for by the applicant in this CA.

#### CA/54/KOB/2021 IN CP(COMPANIES ACT)/23/KOB/2021 is therefore allowed.

#### 8 **CP(COMPANIES ACT)/23/KOB/2021**

Learned counsel for the Petitioners Shri P.G.Jayashankar and learned PCS for the Respondents Shri Vivek Kumar appeared through VC.

The CP has been filed under Section 241 and 242 of the Companies Act, 2013 alleging oppression and mismanagement against R2 to R4 of the R1 Company. The Petitioners submitted that the affairs of the R1 Company are being conducted in a manner which is oppressive to the shareholders, prejudicial to the interest of the 1<sup>st</sup> respondent Company per se. According to the petitioner, he learnt that the respondent directors have been engaged in malpractices and have been illegally siphoning various amounts due to the R1 Company.

Hence this petition.

Heard the learned counsel for the petitioners as well as learned PCS for the respondents and also perused the records attached with the Petition. Along with 7 reliefs sought in the main CP, petitioners have also sought 3 interim reliefs. However, the learned counsel for the petitioner in his argument insisted to pass orders on interim relief sought under item (ii).

It is noted that the respondents have already filed the counter in this CP, but registry reported that the same has not been scrutinised. Considering the materials on record, I think it would not be justified to pass any order on interim reliefs without perusing the counter and hearing both sides.

The petitioners are directed to file their rejoinder, if any, before the next date fixed.

#### 9 IA(IBC)/80/KOB/2021 IN MA/05/KOB/2020 IN TIBA/1/KOB/2019

Learned liquidator Shri Shawn Jeff Christopher appeared through VC. This is an IA filed by the liquidator for impleading the banks of the Corporate Debtor and seeking co-operation from the banks over the amounts credited in the bank accounts of the Corporate Debtor.

The liquidator submitted that the CD received credit in its bank accounts from untraceable sources. Due to the non co-operation of banks, the liquidator is not in a position to identify the source of receipt. The liquidator is facing significant hardship with respect to unidentified cfredit in the banks accounts.

Hence this application for impleading the Banks as respondents

Heard the liquidator and perused the records. The liquidator is directed to issue fresh notice to the proposed respondents through email and Registered Post with A/D or Speed Post and submit proof of service (Postal Track record or A/D card) with an affidavit before the next date fixed. Registry is also directed to issue notice to the respondents through email. The proposed impleading respondents are directed to file their counter within two weeks positively, in default, law will take its own course. Rejoinder, If any, be filed well before the next date fixed. List the matter on **21.05.2021 for hearing**.

#### 10 IA(IBC)/74/KOB/2021 IN IBA/21/KOB/2019

Learned counsel for the applicants Smt Jeslin appeared through VC. Learned RP Shri Jasin Jose and learned counsel for R2 Shri Sunil Sankar also appeared through VC.

This IA has been filed by the applicant seeking direction to the RP/R2 to consider a resolution plan to be submitted by the applicant in terms of the provisions of the IBC 2016.

Smt. Jeslin sought adjournment stating that her senior Shri Harikumar G. Nair is under quarantine due to Covid 19.

Shri Jasin Jose submitted that the period of CIR Process has already been expired on 08.04.2021 and his position as RP is not in existence. CoC is also not in existence. The submission is Shri Jasin Jose is recorded.

#### 11 IA(IBC)/68/KOB/2021 IN IBA/21/KOB/2019

The applicant alleged that the Resolution Applicant/R2 has failed to infuse funds as provided in the Resolution Plan. Hence the FC filed this petition for liquidation of the CD.
