Learned Liquidator Shri Shawn Jeff Christopher appeared through VC.

This is an MA filed by the Liquidator in the matter of liquidation process in the matter of Achariya Techno Solutions (India) Pvt Ltd. seeking the following reliefs:

- (1) To allow transfer of Rs.1,03,000/- to Corporate Liquidation Account under Regulation 46 of the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016 as receipts for which, the source is not traceable.
- (2) To approve and allow order of priority with respect to Order of the Adjudicating Authority dated 18.02.2021 with available realised funds after meeting such Liquidation Process Cost from 19.02.2020 til 19.05.2021 and an anticipated storage cost of Rs.1,10,400/-- for storing, maintaining and preserving the books, records and documents from the date of order of winding up to a period of 8 years, to the EPF Department.

The liquidator submitted that the Corporate Debtor received credit in its bank accounts from untraceable sources. Due to the non- cooperation of banks, the liquidator is not in a position to identify the source of receipt. Therefore, according to the Liquidator, such amount should be transferred to Corporate Liquidation Account

under Regulation 46 of Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016.

The liquidator has further submitted that he considered the Claims of EPFO made by them in letters dated 6th May 2020 and 12th June 2020 in which the amount due from M/s. Acharya Techno Solutions (India) Private Limited with P.F Code No. KR/TVM/1188107 for the period up to June 2018 has been mentioned.

The liquidator has also stated that the closing balance available to the CD as on 12.03.2021 is only Rs.5,03,698/- after meeting the Liquidation cost and an anticipated storage cost.

The liquidator therefore purports to discharge the liability to the extent of Rs.5,03,698/- to the Employees Provident Fund Organisation department for statutory non-compliance for a value of Rs.46,69,022/- vide Adjudicating Authority's judgement dated 18.02.2021.

I have heard the learned Liquidator. It appears from records that after hearing the liquidator as well as the learned counsel of the EPFO, vide order dated 18.02.2021 in IA/176/KOB/2020, this Tribunal had directed the liquidator to consider the Claims of EPFO made by them vide letters dated 06.05.2020 and 12.06.2020 in which the amount due from M/s. Acharya Techno Solutions Private Ltd for the period upto June 2018 has been indicated, while determining the amount payable to the stakeholders in this matter.

In view of the aforesaid order of this Tribunal, the liquidator is directed to appraise the EPFO the clear picture of the present financial position of the Corporate Debtor including the proportionate amount purported to be payable to the EPFO.

After getting the comments from EPFO the liquidator may approach this Tribunal with the latest status report of the Liquidation Process.

With regard to prayer (1), the liquidator may file an IA, if so advised, for directions to be issued from this Tribunal to the Bank Authorities to trace out the credits in the account of the CD.

With the above directions, **IA(IBC)/69/KOB/2021 IN MA/05/KOB/2020 IN TIBA/1/KOB/2019 is disposed of.**
