### 1 IA(IBC)/126/KOB/2021 IN MA/100/KOB/2020 IN IBA45/KOB/2019

Learned Liquidator Shri Dileep KP appeared through VC.

This IA has been filed under section 47(A) of IBBI (Liquidation Process) Regulations 2016 by the Liquidator seeking exclusion of period of Liquidation by 6 months availing the exclusion period on account of Covid 19 lock down.

Heard and perused the records. The above prayer is allowed vide separate sheets.

The liquidator has also sought permission from this Tribunal to release the security interest from liquidation Estate in regard to the request received from M/s. Daimler Financial Services Pvt Ltd. The liquidator is directed to file another IA for the purpose, if he so desires.

#### 2 IA(IBC)/127/KOB/2021 IN IBA/29/KOB/2020

Learned counsel for the Applicant/Operational Creditor Shri P.V.Vinod appeared through VC.

This IA has been filed by the Applicant/Operational Creditor seeking restoration of the IBA/29/KOB/2020.

Vide order dated 04.12.2020, IBA/29/KOB/2020 was dismissed in view of the withdrawal along with Memorandum of Understanding filed by the Operational Creditor. In the aforesaid order both the parties were directed to strictly adhere to the conditions mentioned in the MoU.

Learned counsel for the OC submitted that the CD has violated the terms and conditions of the MoU and hence this IA to restore the IBA.

#### 3 IA(IBC)/129/KOB/2021 IN IBA/13/KOB/2020

This IA has been filed by the RP under Section 60(5) of IBC, 2016 seeking exclusion of 90 days, ie. from 07.05.2021 to 07.08.2021, from the period of CIR Process and to permit the RP to complete the process by 26.12.2021.
