**IA No.88 of 2021:**

This is an application filed by the Applicants, Smt. Rudramma and Mr. Janardhan, claiming that certain portions of the building were allotted to them in extra on 16.07.2014 and a direction to the Liquidator for conducting the measurements of the land for which the Applicants have ownership over undivided share of land. The land has been given for development by the Corporate Debtor and subsequently when the liquidator was appointed by this Adjudicating Authority and the property was put up for sale. The Applicants in this IA sought a direction



to the Liquidator not to confirm the sale and also seeking the possession of the property. In view of the fact that on 16.07.2014, the Corporate Debtor has clearly informed the Applicants that they are deprived of an area of 595 sq. ft. and thus an area of 295 sq. ft. in the 1<sup>st</sup> Floor and an area of 300 sq. ft. in the 2<sup>nd</sup> Floor by way of adjustments and correct shares were allotted to them. Even though the Corporate Debtor makes it clear that the Applicants were deprived of certain portions of the area in the building, we cannot take it as granted and direct the Liquidator to take measurement of the entire building on the basis of agreement arrived at with the Applicants and also in the presence of the Applicant and if at all it is found that the Applicants are entitled for any developed of such area, the same should happily be allotted to them. Until then, the Liquidator shall not confirm the sale and after the measurements are completed both the parties shall bring it to the knowledge of this Bench the actual measurements and seek appropriate directions to proceed further. A period of four weeks' time is granted for both the parties to complete the measurements and file a report before us. The Engineer to be appointed for taking the measurements shall be chosen by both the parties.

This is an application filed by the Applicant for the approval of the Resolution Plan. Before giving the approval of the Resolution Plan, we would like to know the exact value of the property of the Corporate Debtor measuring 53.83 acres of land together with the Plant and Machinery in which the Corporate Debtor's factory is situated. The IBBI approved Valuers have furnished a report on the valuation of the Plant and Machinery and also of the Land and filed their reports in this

Tribunal. On having seen the valuation done by the IBBI Registered Valuers, this Bench is of the view that the valuation of the property has not been correctly projected and a fresh valuation is required to be carried out to arrive at the exact value of the property. In view of the same, we hereby direct the District Collector, Ananthapuramu District, Andhra Pradesh, to direct the local revenue authorities to conduct the survey and also ascertain exact market value of the land in which the Corporate Debtor's factory is situated. This Bench is making it clear that the exact market value of the property is what this Bench is intended to obtain and not the valuation registered with the sub-registrar or registration authorities. Apart from that, we hereby direct the Resolution Professional to appoint a registered professional mechanical engineer for valuation of the Plant and Machinery, who should be an expert in the relevant field, for the valuation of Plant and Machinery. After the reports of the valuation of the Plant and Machinery and valuation of the Land is made available to us, this Bench will take a fresh view on the total valuation of the Land together with the Plant and Machinery and also see whether the Resolution Plan can be approved or not. Until then, the RP has to concentrate on the full valuation of the property provided to us. We further direct the RP to meet the District Collector, Ananthapuramu District, AP, and collect the entire Survey Nos. in which the Corporate Debtor's factory is situated and coordinate with the revenue authorities / District Collector and also other professionals, and furnish a report to us within a period of six weeks. This order may also be communicated to the District Collector of Ananthapuramu District, Andhra Pradesh.
