## 7 CP/24/KOB/2020

Learned senior counsel for the Petitioner Shri Joseph Kodianthara as well as learned counsel for the Respondents Shri Anil D. Nair appeared through VC. R1 & R2 have filed their counter. Learned senior counsel for the Petitioner submitted that in the counter filed by R2, there is no mention about the proper procedure of appointment of 4<sup>th</sup> Respondent as Director of R1 Company. Therefore, he insisted to pass interim orders on relief (b) sought in the CP, ie to restrain the 4<sup>th</sup> Respondent from acting as the Director of the 1<sup>st</sup> Respondent Company. On the other hand, learned counsel for the Respondents invited the attention of this Tribunal to para 15 of the counter filed by R1&R2, wherein it is mentioned that a Circular Resolution was moved by the R1 Company to the effect of appointment of the 4<sup>th</sup> Respondent as Additional Director of R1 Company and the said Circular Resolution was also served on the 3<sup>rd</sup> Respondent at the address mentioned in the cause title. Refuting this argument, learned senior counsel for the petitioner submitted that R3 was in Dubai during the Lock down period and no notice was served on him regarding the appointment of the 4<sup>th</sup> Respondent as Additional Director of R1 Company. Meanwhile R3 has also filed a memo stating that no notice of resolution was served on him and R2 has never informed him regarding the appointment of 4<sup>th</sup> respondent as Director of the R1 Company.

The learned senior counsel for the petitioner has cited the case of *Needle Industries (India) Ltd Vs. Needle Industries Newey (India) Holding Ltd (1981)* wherein it has been held that power to exercise jurisdiction under Ss.397 and 398 of the Act, cannot be defeated by mere technicalities. Jurisdiction of the Tribunal under the said provisions is of widest amplitude and orders can be passed with a view to bring to an end to the matters complained of or preventing the matters complained of or apprehended.

I have heard both the parties. After perusal of the records, including the Memo filed by R3 Director of the Company, this Tribunal **restrain the 4<sup>th</sup> respondent from acting as the Director of the R1 Company until further orders.**

Jurisdiction of the Tribunal under the said provisions is of widest amplitude and orders can be passed with a view to bring to an end to the matters complained of or preventing the matters complained of or apprehended.
