5 MA/164/KOB/2020 IN IBA/55/KOB/2019

Learned RP Shri Shankar P. Panicker appeared through V C. This is an application filed by the RP seeking directions under Section 12A, read with regulation 30A of IBBI (Insolvency Resolution Process of Corporate Persons) Regulations 2016 along with Rule 11 of NCLT Rules 2016. Heard and perused the records. Orders pronounced. MA/164/KOB/2020 and IBA/55/KOB/2019 are disposed of vide separate sheets.

6 IA/180/KOB/2020 IN MA/9/(KOB)/2019 IN CP(IB)/689/17(CHENNAI BENCH)

Learned counsel for the Applicant in Shri P. Benjamin Paul and learned counsel for R1 Shri Ramalingam appeared through VC. It appears from records that R7 to R9 (applicants in this IA) were set ex parte vide order of this Tribunal dated 11.12.2019 in view of their absence or non-appearance.

This IA/180/KOB/2020 is filed under Rule 49(2) of the NCLT Rules 2016 read with Order IX, Rule 7 of CPC with the prayer to set aside the above ex parte order passed by this Tribunal on 11.12.2019 in MA/09/KOB/2019 after excusing the delay of 291 days that occurred in filing this IA and to permit them to participate in the further proceedings before this Tribunal.

The applicants submitted that when MA/9/KOB/2019 came up for hearing on 11.12.2019, the Respondent No.8 and representing the Respondents No.7 and 9 was personally present before this Tribunal and Vakkalath filed on the same day. The applicants were under the bonafide impression that they being represented by their counsel in the future proceedings. However, this Tribunal had set R7 to R9 ex parte as per order passed on 11.12.2019.

The applicants further submitted that due to the inner re-organization and rearrangement and consequent division of work in the Applicants' offices, the file pertaining to the above case got misplaced and was not easily traceable and after much search, the required file was retrieved only thereafter and the reply was accordingly filed. Even though the case was finally heard on 28.9.2020 and was posted for orders on 22.10.2010, the applicants on enquiry came to know on 12.10.2020 that R7 to R9 were already declared ex parte as stated above in spite of the fact that the reply was filed. The contact between the Applicants and the Counsel in respect of this case was lost due to inadvertent oversight on the part of the Applicants. Hence, there occurred delay of 291 days in filing this IA to set aside the order of ex parte against the applicants passed by this Tribunal on 11.12.2019. The applicants submitted that there is no wilful or deliberate laches or negligence on the part of the Applicants herein in prosecuting their case pertaining to their claim against the CD before this Tribunal.

I have heard the learned counsel of both the parties. It appears that the reasons stated in the application are sufficient cause to set aside the above ex parte order. The law is well settled that a party cannot be suffered by way of fault of the Advocate. With the aforesaid view, the ex parte order passed by this Tribunal on 11.12.2019 against the applicants in this IA, ie. R7 to R9, is hereby set aside and they are permitted to participate in the further proceedings in MA/9/KOB/2019 in CP(IB)/689/2017. IA/180/KOB/2020 IN MA/9/(KOB)/2019 is disposed of accordingly.

Meanwhile it appears that the aforesaid R7 to R9 have already filed counter on 29.1.2020 in MA/9/KOB/2019 in CP(IB)/689/2017. The said counter is taken on record.

The learned counsel for the applicants submitted that R7 to R9, who represent the Kerala Water Authority, is a Government Authority. The KWA is running shortage of funds even in paying salary to its employees and contractors. Hence their legitimate dues are to be considered while disposing of the MA.

Heard the arguments of the learned counsel for the Respondents 7 to 9 in MA/9/KOB/2019 and their arguments have been noted for consideration while disposing of MA/9/KIOB/2019.

7 IA/181/KOB/2020 IN MA/9/(KOB)/2019 IN CP(IB)/689/17(CHENNAI BENCH)

Learned counsel for the Applicant in IA/181/KOB/2020 Shri P. Benjamin Paul and learned counsel for R1 Shri Ramalingam appeared through VC. It appears from records that R7 to R9 (applicants in this IA) were set ex parte vide order of this Tribunal dated 11.12.2019 in view of their absence on that date. Vide order dated 4.11.2020 this Tribunal has already set aside the said ex parte order and the applicants in this IA (R7 to R9) are permitted to participate in the further proceedings in MA/9/KOB/2019 in CP(IB)/689/2017.

This application is filed under Rule 11 of NCLT Rules, 2016 to advance the case and the applicants be heard in .MA/9/(KOB)/2019 IN CP(IB)/689/17. Since this Tribunal vide order dated 4.11.2019 in IA/180/KOB/2020 in MA/9/KOB/2019 in CP(IB)/689/17 has already permitted the applicants to participate in the proceedings in MA/9/KOB/2019 in CP(IB)/689/2017 and heard the arguments of the learned counsel for R7 to R9, this IA/181/KOB/2010 has become infructuous. IA/81/KOB/2020 is therefore disposed of as infructuous.
