It appears from records that the IRP has not yet made any formal request to the District Collector with regard to any assistance required from the Police Department. The IRP has also not requested the suspended directors to hand over the required documents to enable him to complete the CIR Process. Anyhow, IRP is directed to give formal request to the Superintendent of Police, Trichur seeking assistance from Police Department, if required, in connection with the Corporate Insolvency Resolution Process against the Corporate Debtor, stating specifically the force required for the purpose. The RP has to bear the costs for the assistance provided by the Police Department. If request is received, the Superintendent of Police, Trichur shall make arrangements for police assistance to the IRP.

The Corporate Debtor M/s. Goodwin Packpet Pvt Ltd and its suspended Directors Kavath Achuthan Anirudhan, Muraly Narayanan, Cheerambath Manikutty Rajeevan, Puthuplally Pavithran Sathees, Prasanth Kumar Santhosh Bhavan Krishnan Nair and Suresh Babu Kattappilly are directed to co-operate with the Interim Resolution Professional. The suspended directors are also directed to provide the documents listed (i) to (v) to the Interim Resolution Professional without fail, at any rate, within 7 days from today.
