## 7 MA/168/KOB/2020 IN TIBA/31/KOB/2019 & TIBA/10/KOB/2019

Learned RP Shri P.D.Vincent appeared through VC. Learned counsel for R1 Shri Parameswaran Nair also appeared through VC.

This is an application filed by RP under Section 60(5) of IBC, 2016 for appropriate direction to the R1 (Committee of Creditors) for providing funds towards the CIRP costs and to co-operate with the Resolution Professional. The RP submitted that he is not in a position to exercise his duties under the CIRP as the R1 is taking contradictory decisions and is not making payments towards the CIRP Cost. The Applicants Mr. Vijayakumar J and others had provided only Rs.1,28,500/- against Rs.2,00,000/- directed by this Tribunal. According to the RP, the CIRP costs amounting to Rs.52,96,243/- is due for payment as on 1.9.2020 and no funds are available with RP for further proceedings.

The Authorized Representative for R1 (COC) submitted that the claim of the Applicant/RP has not been approved in the 7<sup>th</sup> meeting of the Committee of Creditors held on 10<sup>th</sup> August 2020 and that the CoC is not in a position to afford any payment. However, the RP may find out the resources from the assets of the Corporate Debtor, so that from that amount, his payment may be released. He submitted that he shall file a detailed counter on behalf of the CoC in this matter. He may do so. The Authorised representative of CoC may file counter within one week. **List on 19.11.2020**.

## 8 MA/75/KOB/2020 IN TIBA/31/KOB/2019 & TIBA/10/KOB/2019

Learned RP Shri P.D.Vincent appeared in the VC. Learned counsel for R1 and R2 Shri Akhil Suresh also appeared through VC.
