### 1 CP/128/KOB/2019

#### 3 CP/32/KOB/2020

Learned counsel for the petitioner Shri Shinu J. Pillai appeared in the VC. This is a petition filed by Shri Wilson Jacob & Others against Kottayam Port and Container Terminal Services Pvt Ltd & Others under Section 213, 241 & 242 of the Companies Act, 2013. Learned counsel for the petitioner submitted that 48.96% of the stake of the Company is with the Government of Kerala through the 8<sup>th</sup> Respondent KINFRA. The project is substantially funded by the Central Government through Assistance to States for Developing Export Infrastructure and Allied Activities Scheme. The Petitioners are the Shareholders of the Company who conceptualized the project and invested their considerable time and money during the incubation stage of the Company. According to the learned counsel for the petitioners the present Management is conducting the affairs of the Company in a manner prejudicial to the interests of the Company, its shareholders and public. Hence this petition.

In the Petition, in addition to main prayer, the petitioners have sought two interim reliefs. I have thoroughly perused the petition and documents attached with the petition. It appears that without hearing the respondents, it is not justified to pass any interim order as prayed for in the petition. As such, the petitioners are directed to issue fresh notice to the respondents by Registered post with A/D and submit proof of service with an affidavit before the next date fixed. Registry is also directed to issue notice to the respondents through email in addition to normal procedure. List on **24.11.2020**.
