In response to the above, R1 Company issued a letter dated 27.8.2020 to the Petitioner-Depositor returning the FD Receipt, not paying the amount payable thereunder, stating that their Bank Account with Federal Bank Ltd remain freezed Hence this petition. Learned counsel for the petitioner-Depositor centrally. submitted that the Company is liable to be directed to forthwith to make repayment of

the aforesaid Deposit with interest due thereon as is claimed by the Petitioner-Depositor.
