Learned counsel for applicant Sri Mohd.Fazil appeared through VC. Learned Liquidator Shri Mahaligam Suresh Kumar along with his learned counsel Shri A.G. Sathyanarayana also appeared through VC. Heard both the parties for some time. Learned counsel for the liquidator submitted that he has submitted counter in the MA through email. But registry is not able to download the said counter due to some network error. Therefore, the learned counsel may file hard copy of his counter within a day or two.

The learned counsel for the Liquidator vehemently opposed the application submitted by the Collector stating that the application itself is not maintainable. He submitted that there are several potential buyers to take over the hospital as an ongoing concern. They are ready to revive the Corporate Debtor. Besides, there are 300 employees in this hospital. Their wages are to be paid uninterruptedly. Moreover, the interests of the stake holders will also be adversely affected if the hospital is given to the District Administration for Covid 19 purpose.

Any way the matter will be considered after receipt of the hard copy of the counter. The applicant may file his rejoinder, if any, before the next date fixed positively. **List on 5.11.2020 for further hearing as Part Heard.**

8 REPORT NO.99/KOB/2020 IN CA(CAA)/06/KOB/2020

Learned counsel for the Applicant Shri Ameerul Millath appeared through VC. He submitted that he has already submitted the Auditors report upto 31st October 2019. Meanwhile the Official Liquidator has filed a report praying before this Tribunal to permit him to engage the Services of Shri Razee Moideen, Chartered Accountant, Ernakulam who is on the panel of Insolvency and Bankruptcy Board of India for taking up the scrutiny of the books of accounts, statutory registers and other relevant records and papers relating to the transferor company. He has also prayed to direct the petitioner company to pay the fees that may be payable to the CA for the above work. Learned counsel for the Applicant submitted that the scheme in no way prejudicial to the transferor company. The registered Chartered Accountant viz: M/s. Varma & Varma have already audited the accounts upto 31.10.2019. However, if the OL is insisting for further scrutiny of the records, he has no objection in doing so.

After hearing the learned counsel for the applicant and on perusal of records, the prayer of OL is allowed. The Official Liquidator is directed to submit his report within two weeks. Registry is directed to issue a copy of this order to the OL through Email and by hand. **The Report of OL is disposed of accordingly**.

9 MA/163/KOB/2020 IN IBA/23/KOB/2019

Learned senior counsel for the Applicant Shri Joseph Kodianthara, learned counsel for the Resolution Professional Shri Vinod PV and learned counsel for the Financial Creditor Shri Vijay V. Paul appeared through VC. Learned counsel for the Union

Bank of India filed vakalath and sought permission to appear through VC. Even though link was provided, due to some technical problem, he informed that he could not appear today.

This MA is filed under section 60 of the IBC, 2016 with the prayer to direct the RP to place the Resolution Plan submitted by the Applicant for consideration by the COC and also to restrain the RP from proceeding with any further/fresh invitation of Resolution Plan.

This Tribunal vide order dated 13.09.2019 has admitted the CIR Process against the Corporate Debtor M/s. Dewa Projects Private Limited based on an IB Application filed under Section 7 of IBC 2016 by the Financial Creditors who are also home buyers of the CD. RP was appointed and the RP constituted the Committee of Creditors, which mainly comprised of the Banks and Home Buyers. The RP issued Form 'G' invitation of Expression of Interest from prospective Resolution Applicants, prescribing eligibility conditions and giving other details vide paper publications. According to the learned Senior Counsel for the applicant, except the applicant, no other person/party has put forth any Resolution Plan. As per the meeting held on 11.8.2020 the last date for submission of the Resolution Proposal was 28.8.2020. However, the Information Memorandum was shared to the applicant only on The applicant, therefore, was constrained to issue a letter dated 6.9.2020. 15.09.2020 seeking extension of time for submitting its Resolution Proposal. The learned Senior Counsel for the applicant submitted that the said request was placed before the CoC and the CoC in the said meeting agreed that the last date of submission of the Resolution Proposal would be extended to 30.9.2020. While the Resolution Plan of the applicant was before the consideration of the CoC, the RP published another Invitation for Expression of Interest to submit Resolution Plan for the Corporate Debtor vide Annexure A16 notification dated 12.10.2020.

The applicant submitted that he has invested substantial human, financial and other resources in preparing and submitting the Resolution Application. An amount of Rs.5,00,00,000/- (Rupees Five Crores only) was deposited as EMD and provisions for a further amount of Rs.1,05,00,00,000/- (Rupees one hundred and five crores only) was made by the applicant for the purpose of implementing the Resolution Plan of the CD.

Along with the main relief, the applicant has submitted 9 numbers of interim reliefs, which include the prayers to stay Annexure A16 notification, direct the RP to permit the applicant to participate in the meeting of CoC and explain his Resolution Plan in detail, etc.

To fortify the argument, the learned senior counsel for the applicant cited the observation made by the Hon'ble Supreme Court in CoC of Essar Steel India Ltd through Authorized signatory Vs. Satish Kumar Gupta reported in 2019(8) MLJ 524.

On the other hand, the learned counsel for the RP opposed the contentions of the applicants. He submitted that it is the CoC only decided to invite fresh Expression of Interest in the matter since the applicant failed to submit his Resolution Proposal

within the stipulated period prescribed by CoC. The learned counsel for the Financial Creditor has supported the arguments of the Applicant.

I have heard both the parties. After perusal of the records, this Tribunal is of the opinion that it would be justified to pass order on interim reliefs sought by the applicant only after getting the counter from the Respondents. The respondents are therefore directed to file their counter within two weeks positively.
