Learned counsel for the Petitioner submitted through VC that the petitioner is a shareholder-Director of R1 Company. The Petitioner is aggrieved on account of the fact that the R2 had mismanaged the R1 Company and failed to file the Balance Sheets and Financial Statements before ROC. The Petitioner is also aggrieved that there is non-disclosure by the R2 with regard to accounts, bank statements and various financial documents and there have instances of embezzlement of the funds of the R1 Company by R2 and even mismanaging the R1 Company into the verge of

bankruptcy and initiation of striking off proceedings before ROC. Hence this petition has been filed under Section 241-242.

Along with the main reliefs, the petitioner has sought 17 numbers of interim reliefs. Learned counsel for the petitioner submitted that though he sought 17 numbers of interim reliefs, he is now insisting only the interim relief Nos. 1, 3, 5, 7 and 8. After hearing learned counsel for the petitioner as well as learned counsel for R2 and on perusal of the whole case records, it is observed that the financial statements of the Company have not been prepared for the last 3 years. The learned counsel for R2 has not made any objection in appointing a Chartered Accountant as sought for by the petitioner as per interim relief No.3.

The petitioner has submitted names of three Chartered Accountants. Out of which M/s Joice Thomas & Associates, Chartered Accountants, (Membership No.239133) 1<sup>st</sup> floor, Panjikunnel Building, TB Road, Pala, Kottayam -686575 is appointed as the Chartered Accountant to prepare the Financial Statements of the Respondent No.1 Company, for the years ending 31.3.2018, 31.3.2019 and 31.3.2020.

The Respondents are directed to maintain status quo with regard to the shareholding pattern of the R1 Company as of today, until further orders.

Registry is directed to issue notice to R1 and R3 through email. Petitioner is directed to issue fresh notice to R1 and R3 through email and by Registered post with A/D and submit proof of service before the next date of posting. All Respondents are directed to file their counter within three weeks. Registry is also directed to issue a copy of this order to both the parties as well as to the Chartered Accountant through email.

The Chartered Accountant will submit the financial statements with a report before this Tribunal within two months. The fee of the Chartered Accountant will be borne by the Petitioner and Respondents 1&2 equally, as per ICAI chart.
