## 1 CA/58/KOB/2020

Learned PCS for the Appellant Shri P.P.Zibi Jose appeared through VC. Orders pronounced. CA/58/KOB/2020 is disposed of vide separate order.

## 2 СР/33/КОВ/2020

Learned PCS for the Petitioner Shri Arun K. Kamalobhavan appeared through VC. This CP is filed by the petitioner Mr. Razooludeen M, representing a group of shareholders of the Company against the respondents M/s. Davani Silks Private Limited and others under section 97 of the Companies Act, 2013. I have heard the learned PCS and perused the records. The petitioner has prayed for the following reliefs in the Company Petition:

- (1) To seek direction to hold AGM for the Financial year ending 31.3.2017, 31.3.2018 and 31.3.2019, preferably to conduct AGM before 21.9.2020;
- (2) To appoint a scrutinizer for proper conduct of the voting in the Annual General Meetings;
- (3) To appoint an expert as the observer to ensure that the meeting is conducted in accordance with the Companies Act, 2013;
- (4) To immune the officers in default including the Board of Directors, other than R2 and R3 for not holding the AGM and relieve the Directors other than R2 and R3, from the disqualification of directors as specified in the Companies Act, 2013; and
- (5) To condone the delay in filing the financial statements and annual returns of the company with Ministry of Corporate Affairs as required under Section 92 and 137 of the Companies Act, 2013.

The learned PCS submitted through VC that the AGM of the R1 Company has already been held on 26.9.2020. As such, I am of the view that the prayers (1) to (3) in the CP have become infructuous. Therefore, the petitioner may take steps to amend the CP, if he so desires. List on 9.11.2020.

Learned counsel for the Appellant Shri Biju Varghese Abraham appeared in the VC. This is an Appeal filed by the Appellant for restoring the name of the Appellant Company in the Register of ROC. The documents submitted by the Appellant in his Appeal include the following:
