Learned counsel for the Appellant Shri Mohan Pulickkal appeared through VC. Orders pronounced. CA/57/KOB/2020 is disposed of vide separate order.

Learned counsel for the Operational Creditor Mr. Sudha Sathwa as well as learned counsel for the Corporate Debtor Shri Pradeep Joy appeared through VC. **Orders pronounced. IBA/17/KOB/2020 Admitted. IRP appointed vide separate order.** 

## 3 CP/35/KOB/2020

Learned counsel for the petitioner Shri Pratap Pillai alongwith Shri Pradeep Joy appeared through VC. This CP is filed by Shri Pramod V against Mary Rani Popular Nidhi Ltd and others under Section 241, 242, 213 and other applicable provisions of the Companies Act 2013 read with Rule 11 of NCLT Rules, 2016. Learned counsel for the petitioner submitted that the petitioner represents minority shareholders and is also representing more than 100 shareholders of R1 Company. He further submitted that R2 to R6 are under investigation for various offences registered by the Kerala Police in various locations for offenses related to acceptance of deposits and its non-repayment by various entities constituted by them. R2 to R6 are in police custody and there is no legitimate authority or Board of Directors operating in R1 Company. The petitioner apprehends that substantial amounts are siphoned off by R2 and R4 from R1 Company for their family concern "Popular Group" to its various entities and the same amounts to misconduct, which requires the intervention of this Tribunal for enabling recovery of the amounts. The learned counsel for the petitioner further submitted that R2 & R6 being directors and key persons related to the Popular Group, which is under criminal investigation, the customers of other Popular Group establishments are taking away money and property of the R1 Company. The same is also affecting the legitimate interest of R1 and its minority shareholders and depositors.

Hence the petitioner filed this petition with a main prayer along with 8 numbers of interim reliefs. Among them, learned counsel for the petitioner insisted to pass orders on interim relief (a) to appoint interim management for R1 Company with a committee comprising of a team of independent professionals as deemed fit by this Tribunal.

I have heard the learned counsel for the petitioner and thoroughly perused the documents attached along with the petition. After meticulously perusing the records I am of the view that it will not be justified to pass interim order without hearing the Respondents. Hence, Registry is directed to issue notice to all respondents through email in addition to normal procedure. The petitioner is also directed to issue notice to the respondents through Registered post with A/d and submit proof of service along with an affidavit before the next date fixed. List on 11.12.2020 for hearing.

## 4 REPORT NO.96/KOB/2020 IN TIBA/31/KOB/2019 & TIBA/10/KOB/2019

Learned Resolution Professional Shri P.D. Vincent appeared through VC along with his learned PCS Shri Nikhil George Pinto. This is a Report filed by the RP. **The report is accepted and taken on record.** Registry is directed to place the report in the appropriate file.

Learned CGSC submitted that they are awaiting the directions from the Ministry to constitute the team of Serious Fraud Investigation against the R1 Company. The Bench advised the CGSC to take early steps to constitute the Investigating Team and submit their report to this Tribunal without delay.

Learned counsel for the Administrator submitted that Auditing is going on and the Auditors may be directed to submit their report at an early date.

**Next date fixed for hearing on 4.1.2021**. Before that date the learned CGSC as well as Auditors M/s. Babu A. Kallivayalil are directed to take necessary steps to file the respective reports.
