Learned counsel for the applicants Shri Shivasankar R Panicker appeared in the VC. Interim Orders pronounced in MA. **Orders on interim reliefs pronounced vide separate order.**

2 CA/43/KOB/2020

Learned PCA for the appellant Shri P.T.Joy appeared in the VC. Orders pronounced. **CA** is disposed of vide separate order.

3 CP/29/KOB/2020

Learned senior counsel for the petitioner Shri Joseph Kodianthara appeared in the VC. None has appeared for the respondents. Registry reported that though interim counter has been filed through email by Shri Anil D. Nair, Advocate, he has not filed his vakkalath in this case. Hence registry did not provide him the link in the VC. Moreover, the counter is bulky having 152 pages and hence print could not be taken.

This is a Company Petition filed under Section 59, 241 and 242 of the Companies Act, 2013 alleging oppression and mismanagement in the R1 Company. Learned senior counsel for the petitioner submitted in the VC that in a similar case, ie. CP/24/KOB/2020 this Tribunal passed an interim order dated 28.8.2020. Here also the allegation against the Respondents are almost the same. The petitioner alleged that the Respondents have not complied the provisions of Section 62 of the Companies Act, 2013 with regard to further Issue of shares. It is also alleged that the entire loan procured for the R1 Company is under the collateral security furnished by the petitioner. There is also an allegation that the 2nd respondent has siphoned off money from the 1st respondent company and has possession of all the cheque books of the R1 Company of which he is the sole signatory. The petitioner has also submitted that the 2nd respondent has appointed his wife (R4) into the Board of Directors of the R1 Company illegally by submitting concocted documents. In the petition, the petitioner has sought eight interim reliefs. The learned senior counsel for the petitioner submitted that unless interim orders as prayed for in the petition are passed, the petitioner will suffer irreparable loss and injury and will be gravely prejudiced.

I have thoroughly perused the case records as well as the documents appended with the petition and also heard the arguments of the learned senior counsel for the petitioner. Learned counsel for the petitioner has limited his interim prayers to (a), (d) & (e) at present.

Considering the relevant facts and circumstances of this case, I direct the R1 company to ensure that no cheques are issued or any transaction involving financial implications are carried out without the signature of all directors or their nominees until further orders. The R1 company is directed to grant the petitioner free access to the books of accounts and all documents of the R1 Company. R1 and R2 are also directed to file before this Tribunal the documents sent to the Petitioner (including the proof of service) for the rights issue dated 22.3.2018, 31.3.2019 and 31.12.2019, including but not limited to the notice of board meeting and EGM for increasing the authorised share capital (including the proof of service), offer letter, relinquishment letter, attendance sheet, etc.

The respondents are directed to file the hard copy of interim counter before the next date fixed. The respondents may also file their reply to the CP and the petitioner may file their rejoinder, if any, to the reply. List on 16.10.2020.

4 CA/52/KOB/2020

Learned counsel for the appellant Shri R.Krishna Kumar appeared through Audio Conference. He submitted that the Company is an ongoing concern. Report of ROC is on record. Reserved for orders. **List for pronouncement of orders on 15.9.2020.**

5 CA/53/KOB/2020

Learned counsel for the Appellant Shri Sherry Samuel Oommen appeared through VC. It appears from records that ROC has not filed his report. The Appellant Company is permitted to carry out the operation of the above Bank Accounts solely for the purpose of the Appellant Company's business. List on 22.9.2020

Learned counsel for the Financial Creditor Shri Sadchith P. Kurup appeared in the VC. Learned counsel for R1 to R3 Shri P.V.George and learned counsel for R4 Shri

Sivasankar G. also appeared in the VC. Today the case is posted for filing the rejoinder. Learned counsel for the FC submitted that he could not file the rejoinder due to the shortage of stamp paper and hence sought an adjournment. The FC is directed to file their rejoinder within one week. Both the parties are also directed to file their written argument notes before the next date fixed positively.
