1 IA/44/KOB/2020 IN CP/02/KOB/2020

Learned counsel for the applicants Dr. Ravi Chandran as well as learned senior counsel for the respondent in IA Shri Aravind Pandian appeared in the VC. Orders pronounced. IA/44/KOB/2020 is disposed of vide separate order.

Learned senior counsel for the petitioner in the main Company Petition Shri Aravind Pandian requested to post the main CP for hearing at an early date. It appears from records that the respondents have not yet filed their counter in the CP. Respondents may file their counter in the CP within two weeks with a copy served to the petitioner and the petitioners may file their rejoinder, if any, within another two weeks thereafter. Learned PCS for the applicant in MA Shri Nikhil George Pinto, learned counsel for R1 and R2 Shri Akhil Suresh and learned PCS for R6 Dr. Ravi Chandran appeared in the VC.

Shri Nikhil George Pinto submitted that the Hon'ble NCLAT has stayed the order passed by this Tribunal on 12.3.2020 in IA/3/KOB/2020 in TIBA/10/KOB/2019 and in IA/4/KOB/2020 in TIBA/31/KOB/2019 on an appeal filed by Securities and Exchange Board of India, till the next date of posting. The case is posted before NCLAT on 16.9.2020. But Registry reported that we have not yet received the stay order from NCLAT.

This MA is filed by the RP under section 60(5) of the IBC 2016 for appropriate direction for Investigation into the affairs of the Company by an Inspector or Inspectors appointed by the Central Government. It appears from records that Respondents have not yet filed their counter in the MA. Shri Akhil Suresh submitted that he will file the counter for R1 and R2 within a week. Dr. Ravi Chandran sought two weeks time to file the counter for R6 stating that his client is now at Trivandrum. Request is allowed.

4 MA/116/KOB/2020 IN TCP/25/KOB/2019

Learned PCS for the applicant in MA Shri Bijoy P. Pulipra as well as learned counsel for R1 and R2 Ms Harini appeared in the VC. It appears from records that based on the Memorandum of Settlement entered into between the parties, this Tribunal disposed of the TCP/25/2019 vide order dated 17.2.220. This MA is filed under Rules 15 and 153 of the NCLT Rules, 2016 praying for the leave of this Tribunal to enlarge the period of payments by granting six more months time to make the first tranche of payment and to make subsequent tranche payments with 6 months difference each as per details given in the Revised Schedule.
