# 1 CA/51/KOB/2020

None has appeared for the parties. Orders pronounced. CA/51/KOB/2020 is disposed of vide separate order.

# 2 CA/55/KOB/2020

Learned counsel for the Appellant Shri Bijoy P.Pulipra submitted an email seeking an adjournment for two weeks stating that his father passed away this morning. Shri Ponnan Alex G.R., Advocate submitted an email stating that he will be filing the vakkalath for the Respondents before 21.9.2020 and sought an adjournment. List on 15.10.2020.

# 3 CA/56/KOB/2020

Learned PCS for the Appellant Ms..Lekshmi N. appeared in the VC. She submitted that the Appellant Company is an ongoing concern. Along with the Appeal, the appellant has submitted the financial statements and also the income tax return. Anyhow I have to hear the ROC. Registry is directed to issue notice to ROC through special messenger. Appellant may also pursue the matter with the ROC. Let a copy of this order be issued to the Appellant. List on 24.9.2020, before that date ROC may file his report.

# 4 REPORT NO.92/KOB/2020 IN IBA/52/KOB/2019

None has appeared for the RP. Shri Sivasankar R. Panicker appeared for the CD. Report No.92 is filed by the RP regarding the change of Committee of Creditors. Report is accepted and taken on record. Registry is directed to place the Report in the appropriate file.

# 5 IA/105/KOB/2020 IN IBA/25/KOB/2020

Learned counsel for the Applicant/Corporate Debtor Shri Jithin Saji Issac as well as learned counsel for the Financial creditor/Respondent in the IA Shri Leo George appeared in the VC. This IA is filed by the CD raising maintainability of the IB Application as a preliminary issue stating that the power of attorney produced by the FC does not authorize the signatory of the application to file the application under IBC. Registry reported that the Counter filed by the FC in the IA is defective. Shri

Leo George submitted that he will cure the defect within a day or two. Heard both the parties. Orders reserved. List for pronouncement of orders in the IA on 24.9.2020, before that date the FC may cure the defects of their counter filed in the IA.

#### 6 IBA/25/KOB/2020

Learned counsel for both the parties appeared in the VC. Learned counsel for the CD Shri Jithin Saji Issac submitted an email stating that the Managing Director of the CD is in Critical Containment zone and is under strict lockdown since 26.8.2020. Hence, he sought one months' time to file the written statement/counter in the IBA. Today arguments of both the parties were heard in the IA of this IBA and reserved for orders on 24.9.2020. Both the parties agreed to post this IBA on that date. Hence list on 24.9.2020, before that date the Corporate Debtor may file their Counter in the IBA.

### 7 IBA/26/KOB/2020

Learned counsel for the Applicant Shri Regi George appeared in the VC. Learned PCS for the petitioner Shri John Vadassery as well as Learned PCS for R1 and R3 Shri Krishnan Unni and learned counsel for R2 Shri Prashant Kumar appeared in the VC. Learned counsel for the petitioner argued the matter. Learned counsel for R2 submitted that he is not filing any counter. R1 and R3 has already filed their argument notes. Arguments of learned counsel for R2 concluded. List on 22.9.2020 at 2.30 PM for the arguments of the Learned counsel for the petitioner as part heard.

#### 9 **CP/17/KOB/2020**

Learned counsel for the petitioner as well as learned counsel for R4, R6 and R8 submitted an email stating their willing to argue the matter through VC.
