Sanjay, learned counsel for the applicant sought interim relief to suspend the voting power and all other rights attached to the said 4102 shares until disposal of this CA. Shri Sukumar Oommen vehemently opposed the interim relief sought by the applicant and submitted that the CA is not maintainable in view of the fact that all affected parties have not been made parties in this CA. He submitted that he will be filing the counter shortly. Learned PCS for R4 supported the arguments of the learned counsel for the applicant. I have heard the learned counsel for both the parties and thoroughly perused the whole records produced along with the CA. I think it would be justified to pass orders on interim relief only after perusal of the counter. Therefore, respondents may file their counter within two weeks. The Applicant is directed to issue fresh notice to R6 through email and Registered Post with A/D and submit proof of service with an affidavit in this Tribunal before the next date fixed. Registry is also directed to issue notice to R6 through email in addition to normal procedure. List on 22.10.2020.
