IA/142/KOB/2020

Learned RP Shri Jasin Jose appeared in the VC. This is an IA filed by the Resolution Professional under Section 40(2) of CIRP Regulation and as per Section 12(2) of IBC 2016 for extension of time period of Corporate Insolvency Resolution Process. Learned Resolution Professional submitted that the 180 days of CIRP period has been ended on 13.09.2020 (excluding the lockdown period of 63 days) and this application is filed to extend the CIRP period from 13.9.2020 to 12.10.2020 (30 days). The prayer is allowed. RP is directed to complete the CIR Process on or before 12.10.2020. IA/142/KOB/2020 is disposed of vide separate order.

IA/145/KOB/2020

Learned RP Shri Jasin Jose appeared in the VC. This is an IA filed by the RP under section 43(1) of IBC, 2016. It appears from records that the RP has not made any specific prayer in his application. Learned RP submitted that he requires one-week time to file a proper IA. He may do so. List on 7.10.2020

6 MA/142/KOB/2020 IN TIBA/03/KOB/2019

Learned counsel for the applicant Shri Sandeep Gopalakrishnan as well as learned counsel for the RP Shri Vinod PV appeared in the VC. This is an application filed by the application under Section 60(5) read with Section 25 of IBC 2016. Learned counsel for the applicant submitted that as per direction from the Regional Labour Commissioner (Central), Trivandrum to the Managing Director of the Corporate Debtor, the applicant is entitled for gratuity and interest thereon from 1.12.2017 till the date of actual payment.
