The Counsel for the Fourth Petitioner Company further submits that as directed by this Tribunal, notices have been served upon all the Regulatory Authorities namely, (i) concerned Income Tax Authorities with in whose jurisdiction the Petitioner Companies assessments are made, (ii) Central Government through Regional Director, Western Region, Mumbai, (iii) Registrar of Companies (iv) Securities and Exchange Board of India (SEBI) (v) BSE Limited. No representation is received by the Fourth Petitioner Company from any Regulatory Authority. The standard set of information has been submitted to the office of Regional Director by the Fourth Petitioner Company and no further information has been sought for by the office of Regional Director.
- 10. At least 10 days before the date fixed for hearing, the Petitioner Companies undertakes to publish the notice of hearing of the Petition in two local newspapers viz. "Free Press Journal" in English and "Navshakti" in Marathi, both having circulation in Mumbai.

11. The Petitioner Companies to file an affidavit of service regarding the directions given by the Tribunal and do report to this Tribunal that the direction regarding the issue of advertisement of the notice has been duly complied with.
