- The Learned Advocate for the Petitioner Companies further 5. submits that as directed by this Tribunal notices along with copy of Scheme have been served upon the: - (i) concerned Income Tax Authority with in whose jurisdiction the relevant Petitioner Company's assessments are made; (ii) Central Government through the office of Regional Director, Western Region, Mumbai; (iii) the Reserve Bank of India; and (iv) Registrar of Companies and (v) the Official Liquidator (with respect to the meetings of the First Petitioner Company, the Second Petitioner Company and the Third Petitioner Company). Notice has also been served upon the unsecured creditors of the Third Petitioner Company and the Fourth Petitioner Company. The Chairpersons appointed for the meetings of the equity shareholders of the respective Petitioner Company have filed an Affidavit of Service on 13th October, 2017 with proof of service upon the regulatory authorities and proof of publication. No representation has been received by the Petitioner Companies from any Regulatory Authorities or creditors.

- 6. Atleast 10 days before the date fixed for the hearing, Petitioner Companies to publish a notice of the hearing of this petition in two local newspapers viz. "Times of India" (English Edition in English language) and "Maharashtra Times" (Marathi Edition in Marathi language), both having circulation in Pune, as per Rule 16 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016.
- 7. The Petitioner Companies to file an affidavit of service regarding the directions given by the Tribunal pertaining to the advertisement of notice of hearing and do report to this Tribunal that direction regarding the issue of advertisement has been duly complied with.
