MINUTES OF THE ORDER

UPON the application of the Applicant Company above named by a Summons for Direction AND UPON HEARING Ms.SanidhaaVedpathak, Advocate for the Applicant Company, AND

UPON READING Application along with the Notice of Admission dated 8th day of September 2017 of Ms.Bhavika Shah, Authorised Signatoryof the Applicant Company, in support of the Summons for Direction and the Exhibit therein referred to, IT IS ORDERED:-

- 1. That a meeting of the Equity Shareholders of Amfin Consulting Private Limited, "the Applicant Company" be convened and held at its Registered Office at Avashya House, at 5th Floor, CST Road, Kalina, Santacruz (East), Mumbai 400 098, Maharashtra, India, on Monday, November 27, 2017at 11.00 a.m. for the purpose of considering, and if thought fit, approving, with or without modification, the proposed Scheme of Amalgamation of Southern Terminal and Trading Private Limited and Amfin Consulting Private Limited, the Transferor Companies with AGL Warehousing Private Limited, the Transferee Company.
- 2. "Free Press Journal", in English language and translation thereof in "Navshakti", in Marathi language, both having circulation in Mumbai.

4. That the Applicant Company undertakes to:-

- (i) issue Notice convening meeting of the Equity
 Shareholders as per Form No. CAA2 (Rule 6) of the
 Companies Compromises, Arrangements and
 Amalgamations) Rules, 2016;
- (ii) issue Statement containing all the particulars as per Section 230and other applicable provisions of the Companies Act, 2013;
- (iii) issue Form of Proxy as per Form No.MGT-11;
- (iv) advertise the Notice convening meeting as per Form No.CAA.2 (Rule 7) the Companies (Compromises,Arrangements and Amalgamations) Rules, 2016;
- (v) The said undertaking is accepted.

- 5. That Mr.Adarsh Hegde, Director of the Applicant Company be appointed as Chairperson of the meeting of Equity Shareholders and failing himMrs.Arathi Shetty, Director of the Company and failing her, Mr.Jatin Chokshi, Authorised Officer of the Applicant Company be appointed as Chairperson for the above meeting of Equity Shareholders to be held at its Registered Office at Avashya House, at 5th Floor, CST Road, Kalina, Santacruz (East), Mumbai 400 098, Maharashtra, India, on Monday, 27th November, 2017 at 11.00 a.m. or any adjournment or adjournments thereof. The scrutinizer for the meeting shall be Mr. Anil Vasant Mayekar failing him Mr. Jatin Prabhakar Patil, Partners of Mayekar & Associates, Practicing Company Secretaries.
- 6. The Chairperson appointed for the meeting to issue the advertisement and send out the notices of the meeting referred to above. It is further directed that the Chairperson of the meeting shall have all powers as per the Articles of Association and as per provisions of the Companies Act, 2013 and also under the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 in relation to conduct of the meeting including for deciding any procedural questions that may arise at the meeting or at any adjournment or adjournment(s) or any other matter including an amendment to the proposed Scheme or Resolution, proposed at the meeting by any person(s) and to ascertain the decision of or the sense of the meeting by a poll.
