## **ORDER**

- 1. The present Company Application bearing CA No.171 of 2017 is filed by Mr. Kranthi Kumar Kedari, IRP, appointed by this Tribunal, under rule 11 of NCLT Rules, 2016 R/w Section 9 (2) & (3) of Insolvency and Bankruptcy Code, 2016 by seeking the following:
  - a) Implead the Respondents/ Proposed Respondent Nos. 2 & 3 herein as Respondent No.2 (i.e., Power Grid Corporation of India Limited & Respondent No.3 (Axis Bank Ltd) in the present company Application.
  - b) And pass such other further orders as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the case.
- 2. Heard, Mr.Kranthi Kumar Kedari, IRP, Mrs.Sri Preeti Duggirala, learned counsel for the respondent No.1/petitioner and Mr. Nitish Bandary along with P.Vikram, learned counsels for the Respondent Nos.2&3.
- 3. Mr.Kranthi Kumar Kedari, IRP, filed a memo dated 22.09.2017 by stating that during the pendency of the present CA, he has received claims from Axis Bank on 08.09.2017 along with documents and necessary proofs that Axis Bank has made payment of Rs.44,00,00,000/- to the Power Grid



Corporation of India Limited. Hence, he wanted to withdraw CA Nos.170, 171 of 2017.

In view of the above facts and circumstances of the case, the IRP is permitted to withdraw CA No.171 of 2017. Accordingly the CA disposed of as withdrawn.
