## ORDER

Mr S. Bharali and Mr J. Hazarika, learned counsel for the petitioner are present. Mr G. Rahul and Mr M. Das, learned counsel represent respondent No.1.

- 2. Learned counsel for the petitioner submits that in terms of the order rendered by this court on 15.02.2017, notice was sent to the ROC, Shillong, respondent No.2, along with the copies of the petition under Section 97 of the Companies Act, 2013 and connected documents annexed with the petition. It has been submitted that all those papers were delivered to the Postal Department for being served on the ROC, Shillong. In support of such facts, an affidavit has also been filed.
- 3. Perused the affidavit as well as the postal receipt annexed therewith. On perusal of the affidavit, I am of the opinion that the ROC must have received copies of the petitioner aforesaid along with other documents in the meantime. However, the

- 5. Mr A. Das, learned counsel and Mr S.K. Baid, PCS are also present in court. They submit that they have filed an I.A. seeking impleadment of the applicant therein in the present proceeding as party respondent. In that connection, they have submitted that the applicant has huge stake in the outcome of the present proceeding.
- In view of the above, it is ordered that the connected I.A. be also listed along with this proceeding on 24.03.2017 for rendering necessary orders on the application. The applicant is directed to furnish copy of the I.A. and connected papers to the respondents by tomorrow, 03.03.2017, for filing their objection, if any. The applicant may file rejoinder, if any, on the next date without fail.
- 6. Let the matter be listed on 24.03.2017.
