ORDER


1. The present Company Application bearing CA No.262/252/HDB/2017, is filed by BRS Refineries Private Limited, under Section 252 of the Companies Act, 2013, seeking to direct Registrar of Companies to file his report



with this Tribunal so as to restore the name of the company in the Register of Registrar of Companies, etc.

2. Heard Shri Y. Suryanarayana, Learned Counsel for the Applicant Company.
3. The Learned Counsel has submitted that the Company has generated a substantial revenue of Rs. 221,03,40,009/- as on 31.03.2016 and for the year 2017 generated a revenue of Rs. 265,35,96,879/-. The Learned Counsel also submitted that the Appellant Company's bank account is frozen, about 80 employees are working and they are unable to pay their salaries. Therefore, he insisted for interim orders.
4. We have considered the pleadings of the Learned Counsel and perused the material documents in support of the case and passed the following interim orders:
 - (a) Directed the RoC to accept all the pending returns/ Balance Sheets, financial statements / other documents to be filed up to 2017 along with applicable fees.
 - (b) The Learned Counsel undertakes to file an affidavit regarding cash deposited / received during demonetization period.
 - (c) RoC is also directed to submit its report latest by the 3rd week of January, 2018.
 - (d) Post the case on 02.02.2018.
