ORDER

- 1. Heard Mr.D.V.K.Phanindra, Learned Counsel for the Petitioner and Mr.Ramesh Chandra Mishra, Registrar of Companies and MCA.
- 2. The Learned Counsel for the Petitioner submits that M/s. "Venimpex Projects & Constructions Private Limited", was incorporated under the Companies Act,1956 on 03.04.2006 as a Private Limited Company with its CIN:U45200TG2006PTC049684. The main object of the Company is to carry on the business of builders, contractors, designers, architects, decorators, consultants, contractors of all types of buildings and structures including houses, flats, apartments and other related activities. The Authorized Share Capital of the Company is Rs.5,00,000/-(Rupees five Lakh Only) and Paid Up Capital is Rs. 1,00,000/- (Rupees One Lakh Only). On account of non-filing of Annual Accounts and Annual Returns for the Financial Years from 2012-13 to 2015-16 & 2016-17, the Respondent was to presume that the Company has not undertaken any business and humbly submits that non filing is occurred inadvertently and was neither deliberate nor willful. The RoC herein has issued Notice in the Form of STK-5, dated 05.05.2017 and STK-7, dated 21.07.2017 for striking off the name of the Company from the Register maintained by the RoC, Andhra Pradesh and Telangana.
- 3. The Company is having financial obligations and was unable to continue its operations and it is only due to the circumstances beyond control of the Company, that the Company could not comply with statutory Compliances. Therefore, urged the Tribunal to consider and pass Interim Orders by directing RoC to change status of the Company from "Stike Off" to Active; to restore and activate the Company; to activate the DIN'S of the Company, while pending the main Company Application, in the interest of the Justice and equity.



- 4. We have Perused all the Pleadings and also the Provisions of Section.252(3) of the Companies Act, 2013 R/w. Rule 87A of the NCLT(Amendment) Rules,2017 and other applicable provisions of Company Law.
- 5. We are of the primafacie view that the name of the Company was removed without duly following the extant provisions of Company Law and principles of natural Justice. However, all the Contentions of the Applicant has to be considered, at the time of hearing of the main Company Application, after filing report by RoC. In order to ease of doing business and in the interest of Justice, and equity, it is necessary to pass Interim Order, while pending C.A.

Therefore, the following Interim Order is passed pending the main company application:

- a. The Respondents is directed to change the Status of M/s "Venimpex Projects & Constructions Private Limited", from 'Strike Off" to Active (for e-filing). To restore and activate the DINs of the Directors of the company within 7 days from today;
- b. Permitted the Company to upload its pending Annual Returns along with prescribed fees/additional fee/fine as decided by RoC within 30 days from today;
- c. The RoC directed to Communicate the Restoration of the name of the Company to the bankers of the Applicant Company so as to defreeze the account of the Company with their bankers
- d. RoC is directed to file his report on the main Company petition within 4 weeks. Post the matter to 22.03.2018.
