
It is also submitted that the name of the parties in CP No. 156(ND)/13 is wrongly mentioned as Om Prakash Gupta Vs Revex Enterprises Pvt. Ltd., where it should be Om Prakash Gupta Vs. Apex FRP Chemicals Pvt. Ltd. The same be corrected. Henceforth due care should be taken in listing the matters.



Both CP No. 156(ND)/13 and 157(ND)/13 are under Section 397 and 398 of the Companies Act, whereas CP No. 10/163/14 and 11/163/14 are under Section 163 of the Companies Act. Ld. Counsel for the Petitioner prays for some to file the Rejoinder in CP No. 111/163/14. Though all matters were listed for final arguments today. It would be expedient and in the interest of justice to have the Rejoinder in CP No. 11/163/14. Let the same be filed.
